

**The Minutes of
Honeyville City Planning Commission
October 23, 2024 Regular Meeting**

Laurie Hunsaker called the meeting to order at 7:00 p.m.

Present were Chair Laurie Hunsaker. Commission Members Jacob Jaques, Bob Kosbab, Ty Walker, Cherisse Kaminska, Kelli Shaw and Staci Zilles-Nelson.

Cherisse Kaminska offered the Invocation and led the group in the Pledge of Allegiance.

Public Comment Period:

No comments were made.

City Council Meeting Report – Chair Laurie Hunsaker:

- A. **Report:** Kenny F reported that there was discussion during City Council regarding UDOT cracking down on access off Highway 38. It only wants to allow access every 500 ft. With the current zoning of RR, requiring 200 ft. frontage, this wouldn't allow access for two lots.

Zoning Administrator Report – Kenny Funk:

- A. **Zoning Admin Report:** Kenny F stated that he'd received one business license application.

Administer Oath of Office: Brittiny Chlarson administered the Oath of Office to Kelli Shaw. Kelli has a lot of experience in land use and title work and is excited to help the community.

DISCUSSION ITEMS:

- A. **Define Junk Cars:** Jacob J felt that if a vehicle is not insured or licensed then it would be considered a junk car. There was further discussion that there could be different allowances in an ag zone versus residential. Bob K suggested requiring a conditional use permit for individuals who restore vehicles which would allow an exception for the

required amount of junk vehicles allowed. Kenny F expressed that it is important they still require the area to be organized, such as keeping the vehicles in a shop and off the road. He wants to make sure the residential feeling is kept.

- B. **Subdivision Ordinance:** Laurie H explained that the state legislature passed a law that changes the way municipalities handle their development process. They will no longer go before the City Council. And they will only come before the Planning Commission two times. Because of these changes, the city needs to update their subdivision ordinance before the first of the year.
- C. **Working Meetings:** A committee was created to work on the Subdivision Ordinance. Members of the committee will be Dana, Kenny, Kelly and Jacob. They will get together in working meetings and then present the final draft ordinance to the commission.
- D. **Dual Zoning on Highway 38:** Laurie H explained that on Highway 38 lots are dual zoned. The front portion is zoned RR and behind that is A-5. Due to changes with UDOT the commission felt that it may be better to change the zoning in that area to A-5 or A-5A.

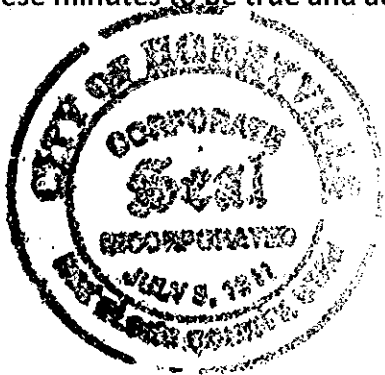
