

**A BUDGET RESOLUTION OF THE SNYDERVILLE BASIN CEMETERY
DISTRICT APPROVING A PROPERTY TAX RATE INCREASE IN
EXCESS OF THE 2024 CERTIFIED TAX RATE**

WHEREAS, pursuant to Utah Code §59-2-919(3), on September 25, 2024, the Snyderville Basin Cemetery District (the "District") provided notice to the county appointing authority of the date, time, and place of the public hearing where the District's budget would be discussed, along with notification of the District's intent to increase property taxes; and

WHEREAS, on October 9, 2024, the District provided the required public statement of the District's intent to increase property taxes; and,

WHEREAS, on October 9, 2024, pursuant to Utah Code §§ 17B-1-1001(3)(b) and 17B-1-1003, the District's Board of Trustees (the "Board") provided the Summit County Council, as the Board's appointing authority, with a report on the proposed property tax increase; and,

WHEREAS, pursuant to Utah Code §59-2-919(3)(c)(iv), on October 29, 2023 the District mailed to all property owners within the District listed upon the assessment rolls of Summit County a parcel specific notice (the "Mailed Notice"), which Mailed Notice included (1) the value of the property for the current year (2024), (2) the tax on the property for the current year, (3) the estimated tax on the property with the proposed property tax increase, (4) the date, time and place of the public hearing on the proposed tax increase (the "Truth-in-Taxation Hearing"), and (5) the statutorily required disclosure statement; and,

WHEREAS, the District has published notice to the general public in the form prescribed by the Utah State Tax Commission of the Truth-in-Taxation Hearing (the "Truth-in-Taxation Advertisement"); and,

WHEREAS, the District held the Truth-in-Taxation Hearing on November 13, 2024; and,

WHEREAS, the Summit County Council, acting as the appointing authority of the District's Board of Trustees and pursuant to Summit County Code 2-44-3, finds that it is in the best interests of the District to increase property taxes in the General fund;

NOW THEREFORE, BE IT RESOLVED, pursuant to Utah Code §§ 59-2-919 and 59-2-220, the Summit County Council, acting as the District's appointing authority, hereby increases the property tax rate, in excess of the 2024 certified tax rate, so as to increase revenue over and above revenue increases for growth, in the Operating Budget by \$495,000.00, or 100%.

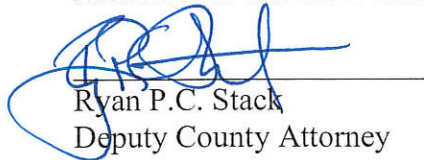
