PUBLIC COMMENT:

David Schmuker stated that they have been working with AES and hopes that the project can go forward and help their area.

John Reese stated that he owns the grazing permit where AES is proposing to do their project. He said that Johanna and Carter have been great to deal with, but he is 100% against the solar farm. If we do continue to move forward with it, we need to make sure we have all documentation in place.

Check Edit Report:

Motion to approve the Consent Agenda, which includes the check edit report and the meeting minutes for October 22, 2024 made by Commissioner Heaton and motion carried with all Commissioners present voting in favor.

REGULAR SESSION:

1. Public Hearing Regarding the Appointment of Johnny Roundy as a Trustee to the 401K Board of Trustees

Devin Reed stated that the reason this has come up is because Isis Smith has been elected as our recorder for the coming year and it has been their policy to not have elected officials on the 401K Trustee Board. They feel that Johnny Roundy would be a great asset to the board.

Motion to go into public hearing made by Commissioner Kubeja and motion carried with all Commissioners present voting in favor.

2. Kane County Resolution No. R 2024-35 a Resolution Appointing Johnny Roundy as a Trustee to the 401K Board of Trustees/Commissioner Heaton

3. Recognition of Isis Smith for Her Years of Service on the 401K Committee/Full Commission

Devin Reed stated that Isis has been serving on the trustee board for around eight years and has been a huge asset and done a lot of good for county employees in that role.

4. SITLA Recommendations: Glen Canyon Solar A, LLC-Shannon McBride/Commissioner Heaton

Shannon stated that this is not like a regular conditional use permit because it is on SITLA land and when it is on SITLA land the commissioner over P&Z has the opportunity to decide how it will move forward. She said that there are several different recommendations and feels like with this change it is more important for AES to work with the county. The concerns that John Reese brought up are her concerns also. She would like to have all the agreements handed into the Land

Use office before they can move forward again. Shannon also mentioned that in the new recommendations she put that the first recommendations are still in effect.

Brady Hewitson gave a presentation on how they are wanting to move forward with the Glen Canyon Solar project.

There was a lot of discussion on this and the Commission decided to put this back on the November 26th agenda for a vote.

5. FY 24-25 Rural County Grant Program Contract with Governor's Office of Economic Opportunity/Commissioner Meyeres

Commissioner Meyeres stated that when the county asks for grants that are more than \$50K the commission needs to approve it. She said that every year we apply for the maximum, which is \$200K and for this year, we have already applied for the grant and received it.

Motion to approve the application for the Rural County Grant Program contract with the Governor's Office of Economic Opportunity with the amount we asked for being \$200K, which was granted to us made by Commissioner Meyeres and motion carried with all Commissioners present voting in favor.

6. Discuss/Vote on Whether to Submit a Grant Application for FLAP (Federal Land Access Program) Funding/Commissioner Meyeres

Kelly Stowell stated that this is a federal program administered through the Department of Transportation. He said that applications are due this week and that it is very competitive. There is just over \$12M for Utah as a whole. We are going to ask for funding for the Coral Pink Sand Dunes road. Kelly also mentioned that there is a 20% match requirement, which can be in-kind.

Motion to authorize Kelly Stowell to submit a grant application for FLAP money with the maximum being \$5M made by Commissioner Meyeres and motion carried with all Commissioners present voting in favor.

7. Discuss/Vote on Pursuing Federal Grant Funding Opportunities for Transportation Within Zion, Once Zion Closes to Oversized Vehicle Through-Traffic Mid 2026/Commissioner Meyeres

Commissioner Meyeres stated that they are exploring every funding opportunity to solve the problem of Zion National Park closing to oversized vehicles mid-2026. There is some federal money that they can apply for with the deadline being the end of this year.

Motion to approve pursuing federal grant funding opportunities for transportation within Zion in the amount for this year of up to \$10M made by Commissioner Meyeres and motion carried with all Commissioners present voting in favor.

8. Discussion/Approval of ALC Amicus Brief Support/Commissioner Heaton

Commissioner Heaton said that American Lands Council has filed an amicus brief, trying to encourage the Supreme Court to take up the lawsuit of Utah versus the U.S. with regard to unappropriated lands. The brief that was prepared and submitted was very expensive so they are asking that the members chip in some.

Motion to support American Lands Council brief, that Kane County is supporting of that brief and that we chip in \$5K to help pay for the drafting of the brief made by Commissioner Heaton and motion carried with all Commissioners present voting in favor.

10. Kane County Ordinance No. O 2024-14 an Ordinance Revising Kane County Land Use Ordinance Chapter 21 Subdivision to Become Compliant with Utah Code 17-27a-604.1/Commissioner Heaton

Attorney Van Dyke stated that this is a significant change and there is no rush to get it passed today. He then went over the changes that have been made mentioning that it is the subdivision process that the new law requires us to change, but when they have had this discussion with the Planning Commission they wanted to change any type of administrative step to no longer having to go to the Planning Commission. Essentially making the Planning Commission no longer the Land Use authority and making Shannon the Administrative Land Use authority.

11. Kane County Ordinance No. O 2024-30 an Ordinance Establishing Rules of Order and Procedure for the Kane County Redevelopment Agency/Full Commission

Commissioner Kubeja mentioned that we had an RDA meeting earlier today and approved this. It is updating the RDA Rules of Order so they comply with the new state statute and other changes.

12. Kane County Interlocal Agreement for Fire Mitigation Projects/Full Commission

Attorney Van Dyke stated that the new structure we have is that the county puts forth money and some of the money is to be used for mitigation projects and it is the county now that gets to decide what those projects are. Under the county's procurement policy, a lot of these projects meet the threshold where we would have to do an RFP or things like that. A lot of the entities that are the only ones qualified to do it are the fire departments for districts or municipalities, which makes it awkward to go through that process when you are just working with a district or fire department. This agreement is allowing the county to have an ongoing relationship with the local fire departments to do these mitigation projects.

Motion to approve the Interlocal Agreement for fire mitigation as presented made by Commissioner Heaton and motion carried with all Commissioners present voting in favor.

Commissioner Heaton stated that Kane County owns the fairgrounds and the North Event Center building and we have had the programming administration of the building itself be handled by the Town of Orderville, which has been policy for decades. As Kane County has made some improvements there, we are trying to decide what makes the most sense.

There will be more conversation on this item on a future agenda.

14. Authorization to File Additional Quiet Title Action Regarding Kane County RS2477 Roads Including the Sand Dunes Road and Other Sand Dunes Area Roads/Full Commission

Motion to authorize additional filing of Quiet Title action regarding Kane County RS2477 roads including the Sand Dunes road and other Sand Dunes area roads made by Commissioner Meyeres and motion carried with all Commissioners present voting in favor.

16. Commissioner Report on Assignments/Full Commission


No reports at this time.
