Opening of Meeting and Roll Call

Duchesne City Mayor Rodney Rowley welcomed everyone to the meeting.

Discussion of the County Subdivision Moratorium

Commissioner Miles explained the reasons for the subdivision moratorium. Duchesne City has put a hold on new accounts, and their water master plan needs to be updated. The parties discussed the health department's requirements for new building permits, residents hauling water, and its challenges.

Carol Conrad with UBAOG gave an update on the past, present, and future goals. They provided transportation for special events, like the Tabiona 4th of July Rodeo, an Oil & Gas Industry tour, and the Duchesne County Fair. The parties discussed the challenges and potential coverage expansion.

Commissioner Irene Hansen explained the requirements for the airport overlay zones and the process thus far. The County will complete a Zoning Ordinance amendment for the Duchesne and Roosevelt Municipal airports.

Discussion of Upcoming Activities and Events

Travel & Tourism Director Ryan Lundstrom said the Holy Fair is November 8th and 9th this year, the Enchanted Forest is November 21st, and the fall festival is this weekend at the Crossroads Senior Center. Duchesne City will have the Halloween trick-or-treating on Main Street again this year. The Energy Summit is in Vernal this week. The rail project will be heard at the Supreme Court in the first week of December. The parties discussed the Highway 191 project and the potential cost of paving Gate Canyon.
