# **Correspondence – Joey McNamee, Library Director**

Joey McNamee shared correspondence from a colleague about the Read Together Program at the jail library. This program allows families to read a book together and then take a book home after visiting an incarcerated individual. The program is funded by the library system and supplemented from programs, such as the Summer Reading Program.

Employees at the jail shared their observations with the program.

- A grandfather came to visit his granddaughter's father. Both the grandfather and father were surprised with the granddaughter's literacy skills and now they read at every visit.
- A lady was overjoyed to find books for older individuals. The staff member noted the lady's smile resulted in a positive experience, even for those not involved in the program.
- A mother, who just got out of the hospital, came to visit her partner during a difficult time
  for their family. The ability to take home books to her children, and say they were from
  their father, was an invaluable gift.

Getting books into homes is important for the overall health of an individual. The Read Together Program is a perfect example of how reading can make a difference.

#### **AGENDA ITEMS**

#### Introduction to Daybreak Branch – Leslie Schow, Branch Manager

Daybreak Manager, Leslie Schow, welcomed the board. The Daybreak branch is LEED Gold and now Net Zero certified. The building has 512 solar panels, geothermal heating and cooling, no natural gas, and 23 solar tubes that act like skylights. The branch received a Net Zero certificate and plaque after sending in one year's worth of information to show the building produced 102% of the power used. The Daybreak Branch is contributing to the power grid instead of pulling from it.

Leslie was congratulated on her Net Zero Certification. Daybreak was built to be energy efficient, but there were multiple actions that the staff had to complete to help reach this

certification. Example of these tasks includes making sure the 3D printer was turned off overnight and determining when the drinking fountain should be operational. The Daybreak staff were thanked for helping reach this goal.

Other interesting building features include the new staircase and retaining wall in the landscape. Patrons who park on the street have mobility issues when climbing the hill. Daybreak has five study rooms, frequented by students and remote workers. A rooftop garden and atrium are enjoyed during favorable weather conditions. They are a popular gathering and meeting place for friends. The Create space is one of the larger rooms in the library system and will soon be seeing more patrons for the holiday season.

There is some confusion regarding if the Daybreak Branch is only for residents. The library is continuing to promote availability for all county members. The branch recently started partnering with Volunteers of America (VOYA), who helps with unsheltered patrons and other issues that arise from being the end of a TRAX line. Other outreach opportunities include schools, refugee communities, and working with American Sign Language (ASL) groups.

Branch staff were recently invited to participate in a neighborhood pumpkin walk to increase collaboration with Live Daybreak. An estimated 2,500 people attended the walk. Stories were shared including a man who said he would only take a goodie bag if there was a library card included. A card was not included, but the bag did have a QR code to sign up for one. Another individual stated she asked her daughter what she wanted to do for her birthday. Her one wish was to visit the library.

An image was shown to the board highlighting the new Downtown Daybreak area. Arrows pointed out the library, a new Salt Lake County performing arts center, and the upcoming Bees Baseball Stadium. The Bee's home opener has been announced for April 8, 2025. A Megaplex Theater is another expected addition to the downtown area.

# **Early Learning Program Overview** – Susan Spicer, Early Learning Program Manager

Early Learning Program Manager, Susan Spicer, received the Sullivan Award for library services to children, from the American Library Association this year. Susan provided slides showing members of her department and a brief history of how they were established by former library leadership. Their goals include nurturing a love of reading and learning by preparing young children for school and life.

Libraries are the only free space for parents to get information about their children, including information on early growth and development. Children develop one million neurons over the first few years of their life. That time is critical to share reading and writing skills.

Reading is one of the most difficult things we do in life and it involves multiple portions of our brains. Someone can sound out a word, but it doesn't mean much if they are unable to understand the word they are sounding out. Many pieces are necessary and are especially important for those learning multiple languages.

In 2004, Susan and Jennifer Fay participated in new program called Every Child Ready to Read. Important elements to this program are talk, sing, read, write, and play. Those five things should be done every day to help children be ready for school.

Storytimes have morphed from kids sitting and listening to books, to a more interactive atmosphere where learning is enhanced through multiple actions. The library now has various types of storytime, which may include yoga elements, take place outside, or be held online during a pandemic.

The library also encourages learning at home with items such as Storytime to Go backpacks, take and make craft STEAM kits, or with programs such as 1,000 Books Before Kindergarten and Books for Baby. A variety of programs and activities are provided to engage patrons at various stages of life and learning.

South Main is a small reading room inside the South Main Clinic that provides books to kids visiting the clinic. Some of these younger patrons are in foster care or are refugees. They come in and select books that are provided in up to 31 languages.

The Storytime Summit is a favorite at the library. Librarians receive training in new techniques and strategies. The feedback is always positive. It is an effective way to help librarians teach kids and their family's literacy and life skills.

- Mayor Wilson presented her budget last week. Budget workshops are now being held weekly. The library budget is moving forward as requested and it will be included with the Community Services Department budget presentation on November 12. The board is invited to attend.
