**I. Board Work Meeting – 6:00 PM**

Board President Danny Little called this meeting to order at 6:00 PM. Other board members present were Karen Kelly and Jarad Brinkerhoff. Others present were Superintendent Dalton, and Business Manager Cary Reese.

The board presented Sheriff Tracy Glover with a plaque to show appreciation for his service to Kane School District to help improve school safety. Tracy thanked the board for the excellent working relationship between the school board and the Kane County Sherriff's department.

Mrs. Libby Button-

Utah Adult Education Teacher of the Year – The board congratulated Libby for all the excellent work she does. The board invited Libby to share things going on in our adult education program. Libby commented on the number of students enrolled in the program. Since she became director, enrollment has increased. This program also covers the Kane County jail. Libby received this award from the State Board of Education.

Supt. Dalton commented on the excellent working relationship between local law enforcement and the school administration.

- C. Interview for Interim Precinct 3 Vacancy

The board interviewed both candidates who have applied to serve for November and December in the open position. Taylor Glover and Tiffany Unsworth.

Supt. Dalton first asked several questions to Taylor Glover. Taylor commented that he wanted to be a part of the school board because he had such a positive experience attending Kanab High School. He commented on the positive effect on his life of teachers and programs as Kanab High. He wants to help make a positive experience for the students at KHS. Taylor commented that he works for Kane County and is familiar with government budgets and how they work. He has to manage the budget for his department with Kane County. He has also helped coach youth sports. He also feels that he has a good pulse on the community.

Danny opened the meeting for public comment. There was none.

**VI. Reports**

- A. Secondary Principal School Improvement Plan Presentations

KHS Principal Trevor Stewart addressed the board and presented the improvement plan for his school. He commented that last year Heather Glover was awarded, best in state for a teacher in business. Some highlights were the KHS growth scores were in the exemplary level, which is very good. He also reported on Aspire + scores. Score improvements in science were especially good. KHS will work hard to improve scores in reading and math for the current year. Attendance is always a struggle. KHS has a goal to keep attendance problems at under 7% for the rest of the current year. Current enrollment credits have significantly increased over the years. KHS will have 20 students who will earn their associates degree's this year. KHS also has students who attend the cosmetology program and will complete the program this year. One KHS student also travels to Cedar City several days each week to attend pharmacy tech classes that the SWTech. KHS is improving instruction through professional development and focusing on data. KHS is using stake holder feedback to improve learning. They have been working to help students understand how getting a good education, will help them in life and in their careers. Karen commented that she has noticed KHS students are happy.

Valley High Principal, Don Heath next presented his school improvement plan to the board. Don commented that VHS has 155 enrolled students. He commented on growth percentages. VHS English language arts scores are very good. Math and science scores are also good as compared to other schools. The school average GPA is 3.607. A couple of students had failing grades. VHS had a 58% reduction in Tardies this year vs. last school year. Goals are to have the school at or above the state average on all state assessments in math and science Spring 2024 to Spring 2025. He also listed Lag and Lead measures. VHS wants all students to feel welcome and safe at school. Mr. Heath presented a complex chart showing different levels of support that are available to students, depending on where they may be struggling. Danny and Jarad thanked Mr. Heath for his excellent service at VHS.

Kanab Middle School Principal Braxton Bateman reported on his school and on his school improvement plan. He is happy with growth percentages in his school. He provided a list of how his ELA, Math, and Science scores compare to several other schools in the State of Utah. Back to School night is very important. KMS makes this a very special and informative night for parents. They also focus on parent/teacher conferences. The 7<sup>th</sup> grade has 92 students. Braxton commented that they purchased guitar's with TSSA funds to give students a variety of learning experiences. Trust Land funds are used to help pay for teacher aides to help with student interventions. KHS exceeded their goals in ELA and Math. KMS had a good celebration for Veterans Day. Braxton reviewed RISE scores in ELA, Math, and Science. The Read 180 program has provided significant help to students. KMS works hard on attendance. KMS is also running a Positive Behavior Program, which is inspiring and helping students. KMS has a full-time counselor who has been providing an excellent service to students who are struggling with personal or family problems.

Student enrollment in October was 1,491, which was an increase of six students from the September count of 1,485.

This includes the 25 BWS students that are bused to Page and 76 preschool students. FY25 October 1 count is 1,408

Supt. Dalton reported that we are concerned about the decrease in student enrollment. This equates to a substantial amount of funding lost.
