BRANDON PHELPS - AFTER BEING SWORN IN, AGENT HELSOP READ THE DISPOSITION. ON JULY 30TH, 2024, MR. PHELPS'S UTAH CONCEALED FIREARM PERMIT WAS REVOKED BASED ON A JANUARY 3RD, 2024 MISDEMEANOR CONVICTION OF LEWDNESS THROUGH THE STATE OF UTAH. MR.
