#### **VOTING ITEMS**

Amend Bullying & Hazing Policy – Janey Stoddard reviewed the amended Bullying and Hazing Policy. These changes are based on the recent changes to HB 84 from the 2024 legislative session. She highlighted the new sections of the policy including new definitions, requirement of notifying parents of the action plan to address verified incidents of bullying, cyber-bullying, hazing, and retaliation, what the action plan must cover, that the school should try to involve parents of involved students in the development and implementation of the action plan, and how the action plan needs to be communicated to parents of involved students. It also makes it clear that students and employees are prohibited from sharing a recording of an act of bullying, cyber-bullying, hazing, abusive conduct and are subject to discipline. There was a discussion on what would happen if filming were shared and clarification on impacting future incidents. It was recommended to end the sentence under the Prohibited Conduct after retaliation and remove "in order to impact or encourage future incidents". David Gray made a motion to approve the Amended Bullying and Hazing Policy with eliminating "in order to impact or encourage future incidents" and end the sentence at retaliation (on the first page under "Prohibited Conduct"). Deb Hansen seconded the motion. The votes were as follows:

➤ <u>Amend Fee Waiver Policy</u> – Janey Stoddard reviewed the amended Fee Waiver Policy with the changes included updating key terms and phrases, no fees can be charged for K-6 remedial programs and fundraising is no longer considered a school fee. **Deb Hansen made a motion to approve the Amended Fee Waiver Policy.** Jimmy Sunlight seconded the motion. The votes were as follows:

Amend Dual Enrollment Policy – Jared Buckley reviewed the amended Dual Enrollment Policy. We currently allow dual enrollment for student who attend school ¾ of the day. It is not mandatory to allow dual enrollment and it makes it very hard to excuse a student for just math when math is taught all throughout the day. Administration truly believes that if a student is going to be successful at LLA then they need to attend our school all day. Chuma Uzoh made a motion to approve the Amended Dual Enrollment Policy including the name change to Dual Enrollment and Split Enrollment Policy. David Gray seconded the motion.
