ADA requirements

Does it have to be inside the residence or accessory building; it can be in a residence or ADU, did not Specify if building was okay.

Council Member Mecham, contacted the school district for a school inspector. The Coburns have a inspection scheduled for October 28. Inspector to review if sprinklers are needed, traffic patterns, and occupancy.

No Action was taken; Application for rezone has been withdrawn

5. Discussion & Possible Action- Define and Illustrate Yard Designations

Gil expressed that City Council liked the idea of having a defined buildable space. There was concern that corner lots had a reduced buildable area. Hard to define a backyard on a corner lot if the house is angled.

Corner lots 30 foot frontage, side yard reduced to 10 ft. instead of 20 ft., which would make their space equivalent to the other lots.

Commission members discussed defining buildable space on a corner lot, Amend Chapter 7 defining corner lots. Commission members will review and discuss at the November meeting.
