Summary

The meeting transitioned from a closed session to a public hearing on proposed fee schedule updates. A motion was made and passed to open the public hearing, where concerns about a new water convenience fee were raised by a town official. Discussion ensued about the costs and logistics of water sampling, with Paradise Town granting \$15,000 for drinking water expenses. The council decided to adopt the new fee schedule, effective January 1, 2025. The next meeting was scheduled for December 11, with a budget hearing set for the same day. The location for the budget hearing was confirmed to be in Logan.

- [] Set a public hearing for the health department budget on December 11th from 1-3 PM in Logan

Public Hearing on Proposed Fee Increases

- Cheryl Atwood announces the end of the closed session and the start of the regular session, noting the time as six o'clock.
- Lee Perry makes a motion to open the public hearing for the proposed fee increases.
 - Second, Cade Palmer

- Cheryl Atwood mentions that her husband, the public works director of Paradise, is unhappy with the new water convenience fee.
- Discussion ensues about the costs and logistics of water sampling. The conversation touches on the number of samples and the fees associated with them.

Fee Schedule and Public Comments

- Cheryl Atwood notes the lack of public comment during the public hearing and suggests a motion to adopt the new fee schedule.

Adoption of the Fee Schedule

- Lee Perry makes a motion to adopt the proposed 2024 fee schedule changes.
 - Second, Kevin Hall.
- The public hearing is closed, and a motion is made to set the effective date of the new fee schedule as January 1, 2025.
- Cheryl Atwood confirms the effective date and asks for any further discussion, which is met with none.
- The motion to adopt the new fee schedule is unanimously approved.

Next Meeting and Budget Hearing

- Bill Cox makes a motion to set a public hearing for the budget on December 11 at 1pm-3pm.
 - Second, Cade Palmer.

Finalizing the Next Meeting Details

- Cheryl confirms the date and time for the next meeting as December 11 at one o'clock.
- The public hearing for the budget is scheduled to be held sometime during the meeting, with the exact time to be decided.
- Cade Palmer makes a motion to adjourn.
