SYNOPSIS OF OGDEN CITY ORDINANCE**

I, Jason Gould, the duly appointed Deputy City Recorder, in and for the City of Ogden, Weber County, State of Utah, do hereby certify the Ogden City Council at its December 17, 2024, meeting adopted the following:

ORDINANCE NO. 2024-35: AN ORDINANCE OF OGDEN CITY AMENDING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2024 TO JUNE 30, 2025 BY INCREASING THE ANTICIPATED REVENUES AND APPROPRIATIONS FOR A GROSS INCREASE OF \$674,100; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-36: AN ORDINANCE OF OGDEN CITY AMENDING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2024 TO JUNE 30, 2025 BY INCREASING THE ANTICIPATED REVENUES AND APPROPRIATIONS FOR A GROSS INCREASE OF \$18,530,850; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-38: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING SUBSECTIONS 4-6-1.B.20 AND 4-6-1.B.21 TO REVISE CHARGES AND REGULATIONS REGARDING REFUSE COLLECTION AND DISPOSAL AND GREEN WASTE MATERIALS; BY AMENDING SECTION 12-2-2 TO REVISE PROVISIONS FOR AUTOMATED REFUSE COLLECTION; BY MAKING TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-39: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING SUBSECTION 4-6-1.B.2 TO REVISE CHARGES IMPOSED FOR CEMETERY SPECIAL SERVICES; TO MAKE TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-40: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING SUBSECTION 4-6-1.B.4 TO REVISE CHARGES IMPOSED FOR THE EL MONTE AND MOUNT OGDEN GOLF COURSES; TO MAKE TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE NO. 2024-41: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING SECTION 3-31-7 OF THE OGDEN MUNICIPAL CODE TO EXTEND THE SUNSET PROVISION FOR THE SUSTAINABILITY COMMITTEE TO DECEMBER 31, 2026; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.
