Joan went over the Open and Public Meeting Act. The default with public meetings is that you conduct your meetings in public. The preference of the Board can certainly be to be as transparent as possible except for those rare cases when they cannot discuss the information in public.

Joan also emphasized the importance of confidentially of Closed Meeting discussions. Failure to adhere to this can expose the individual and the board. Assume everything you say and do will end up on the front page of the newspaper. Class B Misdemeanor if the public meetings act is violated.

The board directly hires the Superintendent and BA. The term of office is 2 years. No exception on continued employment beyond contract term. The board is the appeal body for all employees. 53G-11-512(1).

## **Park City Police Department**

The Board was given an overview of the partnership with Park City Police Department and the School Resource Officer. Officers present included: Wade Carpenter, Frank Smith, Casey Bates, Tim Burger, Skyler Talbott PIO, Todd Davis, and Jay Randall.

Chief Carpenter thanked the Board for their hard work. He states that their relationship with the district is very important. Lt Randall oversees the SRO's in the three schools and will have an additional one with HB84. Mike and Lt Randall have spent a great deal of time together collaborating. Lt. Randall encouraged the Board to let them know how they can serve the district. "We rely on this relationship every day". Sheriff Smith said that our number one priority is our children. We plan for the worse and pray for the best. The County Council approved five new SRO's within Summit County. PCSD is well ahead of other schools in the state of Utah.

Caleb said our partnership with the department is so important. He appreciates the safety that everyone provides. No better partnership than we have right here.

# **Superintendent Community Survey**

District Statistician, Lea Hebert, shared the community survey regarding hiring of a new Superintendent. Eight questions were listed on the survey and there were 1043 responses. This information will be shared at the January 21 Board Meeting.
