#### **Public Comments**

#### Minutes Approval

Mayor Silvestrini moved to approve the minutes from the August 26, 2024, Finance Committee Meeting as submitted.

Council Member Bailey seconded the motion.

All voted in favor, none opposed.

#### 2025 Tentative Budget - CFO Hill

- ♦ CFO Hill provided an overview of the tentative budget in preparation for presentation to the Board in November and final adoption in December.
- Starting with a 2025 baseline amount in January, additional costs for the first new station will be added.
- February recruit camp will include 15 additional FTE's.
- ♦ June 2025, the first station will be staffed.
- October 2025, UFA will hire an additional 15 FTE's for the second station.



- ◆ The second station will open December 2025/January 2026.
- The General Fund expenditures were reviewed.
  - Council Member Bailey asked what the law required for the General Fund Balance minimum; CFO Hill explained 5% is the state law requirement.
- Reviewed were the professional fees provided to UFSA by UFA employees, with reductions due to completion of station construction projects.
- Capital Projects consist of seven projects for consideration by the Board.
  - Also included are standard maintenance projects at the stations.
  - The garage at temporary Station 112, \$600,000, has been pulled from the budget for now.
  - The garage will need to be built if a crew is moved into the house in the future.
- ♦ Council Member Bailey asked that during the potential tax presentation that it be clarified to the Copperton Council that Copperton only contributes \$90,000 for their 3-handed crew.
  - It would be good to point out the benefit to the community and how it is compensated.
- Mayor Overson asked if there will be a lull in remodeling/rebuilding with the remaining stations.
  - Chief Burchett explained that while there will always be maintenance, part of the seismic work was to assess the longevity of each station.
  - Once Station 112 is rebuilt, Stations 109 and 118 would likely be the next for replacement, but they still have at least a 7-10 year lifespan.
  - The majority of the stations are newer and have a longer life, however, maintenance plays a large role in extending their life.
- ♦ Mayor Overson hopes that in the grand scheme and once Station 112 is online, there can be some breathing room before the conversation regarding spending large amounts of money on stations can begin again.

Mayor Silvestrini moved to recommend submitting the tentative budget to the UFSA Board of Trustees for consideration.

Council Member Bailey seconded the motion.

All voted in favor, none opposed.

#### Capital Project Emigration Canyon Station 119 Xeriscape – AC Robinson

- A need to improve the station landscaping was recognized.
- A proposal to complete the landscape as a Firewise model is being considered.
- ♦ This is an opportunity to spend a bit more money but show the residents that Firewise landscaping can look good and is an option to just clearing out fuels.
- ♦ Mayor Overson, as do members of the Board, feel that this is a great idea.
- This cost has already been included in the 2025 Tentative Budget as discussed and voted upon.

#### **Public Comments:**

Included in the packet was an online comment from Rhonda McLeod, who does not support the tax increase.

#### Pam Bennett, Kearns

Opposed, senior citizens can't afford increases when cost of living only goes up 2.5%.

#### Tracy Burkhart, Taylorsville

Ms. Burkhart can see the increase with Eagle Mountain, but with Kearns and Magna those homes are small and even though properties have increased, we are way over scale. Eagle Mountain has two stations with a smaller population. I haven't received a pay increase since 2020 and Taylorsville has three fire stations. Do we share or are we supporting Eagle Mountain? How many ambulances are actually contracted to facilities we have within the district, how many ambulances are housed in stations, or do we contract ambulances? Some of that should be considered with part of the tax increase.

#### Wolfgang Franz,

Opposed to the increase, he looked at his tax notice and the increase in rate is almost 45%. This increase doesn't take into account the increase in houses, every day there are 2-3 new houses built that will be generating tax revenue. Mr. Franz doesn't know what makes us so special to make a 45% increase. His suggestion is to renovate the old engines and stations to make them last longer.

#### Jeff Kuhr,

Mr. Kuhr does not want to give UFA one dime more, and they are only second to UDOT in wasting money. There are two fire stations on 7200 S. with traffic lights, he is tired of us wasting taxpayer money.

#### Michelle Paradise, Taylorsville

Ms. Paradise is opposed to the tax increase, and has also seen large increases with water, garbage, utilities of up to and over 30%, unreasonable. We have paid extra money for new stations already; I am still working I would like to negotiate a proposed 2.3% increase which is more than my salary increase will be. I suggest finding new ways to conserve, make adjustments, or do without.

#### Van Larson, Taylorsville

Mr. Larson is happy to approve/support more pay for firefighters, but not to support administrative increases where the top dogs get all the money and workers don't get enough. The facilities are too pretty, get by with more conservative stations and all government buildings. The jail is better than what it ought to be. We have all been spoiled, everyone has got to tighten our belt, inflation is killing our kids, grandkids, all of us and we better get a handle on it. Pay the firefighters more money, no more to management and facilities.

#### Paul Schmidt,

There is a fire station 2.5 blocks from my house, we are out of control. Just a 20% increase is absurd. I look at property tax revenue, it's almost \$20M above last year, it's insanity, there have to be cuts. Mr. Schmidt understands its hard to get staffing, but this building is taj mahal and isn't cheap, we should be going out for minimum standards, it's absurd.

#### Sue Wiggins, Millcreek

With the extra housing we should generate a lot of revenue, teachers and firefighters don't make enough money. Raise firefighter wages, I am supporting my family on my wages, and it is difficult to make ends meet, the little people are having a hard time.

#### Ted Wiggins, Millcreek

We do appreciate UFA and recognize the needs. We support tax, but we are interested in fair and necessary tax. Our city, Millcreek, is wonderful place to live, we have too much stuff going on. But why turn everything into a place where a normal man can't live. Programs need to be cut back, budgets need to be trimmed, excess fluff, administrative positions, SLCo has so many assistants to the mayor, it's just crazy. You can trim taxes, everyone can, it all adds up and it's killing us. On our modest property in Millcreek, it adds \$200 per year, but think of all the taxing entities. Hundreds of taxpayers attended the SLCo council meeting, and at the end, none of the commissioners cared, they raised taxes. Please consider us, we love you and need you, but we need to live ourselves and we didn't get a 23% increase in our income.

#### Teresa Larsen, SLCo

Ms. Larsen asked if there is any other way to get revenue besides taxes, cutting back, any other way? People are strapped and real estate has been strategically higher, everyone is paying more. As they caught up with tax assessments, the appraisals are closer to what the properties are worth. Any other way besides raising taxes?

#### Ted Wiggins, Millcreek

Addition addendum, like what this lady said about adjust, do without. I have been to council meetings where certain entities talk about bonuses at years end, I can't comment on the budget line items and am confident the budget is full of necessary things and some unnecessary that can be trimmed. You need to look at where you can cut back, all America has had to cut back. Expenses, depending on the category have gone up 80-400 % so we get it, but if all citizens have to do more with less, government agencies must do so as well. You are causing people like us stress, UFA is causing us stress. 99.9% of the public doesn't know about these hearings, so low attendance at these hearings is not disinterest, most people don't know, we need to advertise this tax raise better. Why not say this to all tv stations and see what attendance we get. Please look at our hearts and wallets and help us out.

#### Michelle Paradise, Taylorsville

Ms. Paradise doesn't understand why all the increases over the last 6 years, she has had to work with that and still can't afford all the other increases. She doesn't have enough money to replace her driveway and must do what she has to do and doesn't have money for extra expenses. We need to find creative ways to cover costs, the tax presentation proposal shows increases, our taxes go up every year.

#### **Board Member Response to Public Comments**

#### Mayor Silvestrini, Millcreek

This is painful for us to consider tax increases and the Board does not like folks angry. Mayor Silvestrini appreciates that many folks are on fixed incomes, however, he noted that those on social security over the last 7-8 years have received a 30% increase in Social security, the cost of everything has gone up. This is the problem we are dealing with, everything with the fire department has gone up too. One main things government does is to provide public safety, we don't like to pay for it, but sure want to have it when we need it. Do you want them to respond in 5 minutes or take one-half hour to get there, we could cut the budget and say one-half hour if people would accept that.

There were some comments on the three Taylorsville stations, this budget is expanding service in Kearns so those residents will get better service and West Valley Fire doesn't need to keep coming into Kearns. Service is not based on which city the stations are in, its geography and roads and how quickly they can get to your house, your emergency service comes from the place that can get there the quickest and that is the goal of our fire service.

There is and has been new growth, yes, we benefit from new growth, but that also has the expense of serving it. The way UFSA is set up, there is no other source of income, the only tool is taxes. The UFA Fire Department does charge for ambulance service if transported to a hospital, but they are very limited, by state statute, in what they can charge. But as a public service and as a community, we provide public emergency service to everyone, so residents don't get a bill if their house burns down.

There are no bonuses paid in UFA and administration is pretty lean compared to what they have to do. The department doesn't run if someone isn't administrating it. It takes personnel to pay staff, track how much equipment is used and replace that equipment, they are necessary for the department to run.

Most of the increase is going to firefighters, we have had to confront wage wars amongst other agencies. We have the best fire department in the state because of our firefighters, if we don't pay a competitive salary, they can go to another dept, there is a shortage of firefighters and there is difficulty in finding recruits to staff the services we want to provide. The only thing we have to combat this challenge is salary competitiveness.

With regard to the Taj Mahal, under two prior administrations, stations were built big and taj mahal-ish. Our firefighters live there, but we have adopted a philosophy with the last two administrations to build more modest fires stations. Look at the new stations, they are one story, modest, but effective. We want them effective and want them to have safety equipment to clean engine fumes, and carcinogens out of the air and their uniforms, so they need equipment to wash the turnouts. That kind of stuff costs money, we aren't just buying new equipment, we are trying to use old stuff, we only buy new equipment when we have too, but it does wear out and gets used hard. With the hard duty that this equipment goes through, we want serviceable equipment that can save our lives.

I to am on a fixed income, I got a 7% raise in 8 years, social security has gone up three times more than that in the same period of time. But I recognize the benefit I get and the need to pay for these services, that is why I will vote for this tax increase.

I assure you, we have done all we can to cut the budget.

#### Council Member Hull, Magna

80-90% of this budget is paying firefighters and there is no other way to raise money, we are only allowed tax by the State of Utah.

#### Council Member Harris, Emigration

Thank you to all who came out tonight, none of us on the board are paid. I encourage everyone to follow our meetings via zoom, we could do a better job publicizing the meetings, but we do meet the standards to advertise. We have not been regularly raising taxes, this was done in 2017 and only just last and this year. Everyone who works here looks at every single expense with a fine tooth comb.

#### Council Member Huish, White City

White City participates in UFSA; however, UFA is not first response to White City, we are not getting a direct benefit as other communities might be. Your comments are a good reminder of the impact that we have on the individual level and appreciate all of these public comments. I am not in favor of the 23% increase but reviewing the financials it's hard to justify anything other than that. My community is 1,800 homes with a \$93.00 average increase, it will be hard asking my neighborhood to pay more.

#### Council Member Bailey, Copperton

Copperton opposes taxes whenever possible, but my community understands that I would be completely against the increase if UFA couldn't give me line by line exactly how they are spending their money. The budget is not frivolous, it's not wasted, there are no bonuses, it's not spent on administration. Every dollar spent is shown to the Board at every meeting, this is not an organization that is abusing the system. As hard as it is to see 23%, the Board has made the decision so that moving forward next year, we can avoid another tax increase. I can say, this is not being done frivolously, I can't say that about other organizations, because they don't do what UFA does, so it makes it easier to swallow.

#### Chrystal Butterfield, Kearns

I have to admit, this definitely hurts, Council Member Butterfield offered a story of when her husband needed emergency care while out of town, it took 15 minutes for crews to arrive, and he almost lost his life. My husband is disabled, and I work two jobs. UFA is running on a lean budget; our firefighters work their tails off to make sure the community is taken care of. Kearns Station 107 is not new; we have the second highest call volume of the whole agency. Opening this station will help take the pressure off of neighboring fire departments. If there was a way to get around this, trust me, we would try to do it. When minutes matter, we need to do what is needed to take care of everyone.

#### Tom Westmoreland, Eagle Mountain

I don't like being in this situation at all, I feel it and our family feels financial crunches as well. We are constantly working to figure out how to readjust our budget to make things work. The money we have is worth less, there are things in government that ought to be changed and cuts made, but the area where I have a hard time compromising is public safety. Saving lives and protecting homes, those are our people, and I cannot compromise there and say "well, this is just the best we can do". This isn't a luxury service, but a necessary service and the challenge is that this Board has to create a standard of acceptable service to protect property and save lives. Your comments are heard, and we feel it too, but we have a responsibility to see everyone get services when needed.

#### Rachel Anderson, UFSA District Administrator

DA Anderson explained how the percentages are applied and how property tax works. UFSA asks for a dollar amount and SLCo takes that dollar amount and looks at property values and changes it into a percentage. We always get the same dollar amount, but our same dollar still needs to purchase on increased costs, we don't get to increase what we receive year to year without this tax process. We aren't increasing the size of government, we only do when we have to add staff due to increases in population,

that is the only time. This increase is to help our dollars go the same distance and UFSA was able to go a lot of years without a tax increase. We conducted public hearings, present the potential increase to all councils, posted public notices, and sent cards to every individual home telling them the impact to their homes taxes. DA Anderson noted that there are some services for reduced property tax for those needing that, through SLCo Abatement.

### A RESOLUTION OF THE UNIFIED SERVICE AREA APPROVING THE REVISED "EXHIBIT A" TO THE INTERLOCAL AGREEMENT WITH UNIFIED FIRE AUTHORITY FOR THE PROVISION OF SERVICES

**WHEREAS**, the Interlocal Cooperation Act, Utah Code Ann. §11-13-101 et. seq. (the "Interlocal Cooperation Act"), provides that any two or more public agencies may enter into agreements with one another for joint or cooperative action following the adoption of an appropriate resolution by the governing body of each participating public agency.

WHEREAS, the Unified Fire Authority (the "Authority") and the Unified Fire Service Area (the "Service Area") are public agencies for purposes of the Interlocal Cooperation Act.

WHEREAS, the Authority provides fire protection and emergency medical services to the Service Area and other public agencies for a fee. The Authority has also provided administrative services for Service Area in the past and been reimbursed for the costs of such services pursuant to an Interlocal Agreement approved by the Board on October 17, 2017 and subsequently executed by the Parties (the "Interlocal Agreement").

**WHEREAS**, the Interlocal Agreement provides that for each calendar year the Parties will approve an "Exhibit A" that sets forth the services to be provided and the cost to be paid by the Service Area to the Authority.

WHEREAS, after careful consideration, the Board of Trustees of the Service Area has reviewed the proposed revised "Exhibit A" to the Interlocal Agreement, attached to this resolution as "Exhibit 1," and determined that it is in the best interests of the Service Area to approve it as Exhibit A to the Interlocal Agreement for calendar year 2025 to replace the prior authorized Exhibit A.

**NOW, THEREFORE,** be it resolved by the Board of Trustees of the Unified Fire Service Area as follows:

- 1. The Board hereby approves the replacement of the current Exhibit A with the proposed revised Exhibit A, in the form attached as Exhibit "1" hereto, on behalf of the Service Area, for calendar year 2025, subject to the mutual approval by the Board of the Authority.
- The Service Area's keeper of records is authorized and instructed to keep and maintain a copy of this revised Exhibit A with the Interlocal Agreement available for inspection.
- 3. This Resolution will take effect upon approval. The revised Exhibit A will be retroactively effective to January 1, 2025 and when the following Interlocal

Cooperation Act requirements have been satisfied: (i) the Agreement has been approved by all parties as required by Section 11-13-202(2); (ii) each party to the Agreement has submitted the Agreement to an attorney authorized to represent the said party for review as to proper form and compliance with applicable law as required by Section 11-13-202.5(3); and (iii) the approved Exhibit has been filed with the keeper of records of each of the parties as required by Section 11-13-209.
