##### **DISCUSSION & VOTING ITEMS**

- Design-Construction RFP

Brandie Evans discussed the need for the school to expand the lunch program and facilities associated with it. The board discussed the options for the design-construction RFP. Brandie Evans discussed the proposals that were submitted. The RFP committee reviewed the proposals and scored each on the same criteria. The board discussed the differences in the



bidding process between the two bids. They also discussed that the cost may go up on the lower bid but it still won't hit the expense of the One West bid. They discussed that they have worked with One West before and have not worked with the other company. They aren't concerned about working with the new company. The recommendation from the committee is to approve the proposal from JZW/City Creek. They believe this proposal provides the best value to the school. David Ray asked about the "past performance" area of the rating system and how they scored it. Priscilla Stringfellow and Brandie Evans discussed the concern about meeting deadlines and the project being completed before school starts next fall. David Ray asked if, when they vote, they can put a certain threshold number that can't be exceeded. Brandie Evans reported that they did talk to the company about putting a "not to exceed" number in the contract. A lot of the numbers will depend on the design that is created. The board discussed that if the cost increases dramatically after the design is completed, they can cancel the contract and choose a different company. They discussed that the original bid from JZW and how they noticed a few things missing. Once the company added the permits and other items, the cost came up. The committee recommended awarding the RFP to JZ/City Creek to complete the needed renovation.
