### **LEA-Specific License Policy**

The purpose of this policy is to identify CS Lewis Academy's LEA-Specific licensing / endorsement requirements pursuant to the conditions outlined in Utah Administrative Rule R277-301. The following procedures are established to identify qualification requirements and guidelines for the issuance of CS Lewis Academy-LEA-Specific licensing and endorsements. Procedure:

### **Educator License/Endorsement Requirements.**

- 1. CS Lewis Academy-LEA License Eligibility Criteria. An Applicant shall:
- a. Complete a bachelor's or higher degree in a related field of study; or have exceptional or specialized occupational experience, training, or expertise directly related to the area of assignment; and,
- b. Complete a criminal background check including review of any criminal offenses and clearance in accordance with Rule R277-214; and,
- c. Complete the educator ethics review described in Rule R277-301 within one calendar year prior to the application; and,
- d. Complete the following Professional Learning Modules (linked to the USBE web site):
- i. Educator ethics;
- ii. Classroom management and instruction;
- iii. Basic special education law and instruction; and
- iv. Utah Effective Teaching Standards described in R277-530.
- 2. The Applicant must receive approval from the CS Lewis Academy Board of Directors in a

public meeting. In considering whether to approve an LEA-specific license, CS Lewis Academy shall consider:

- a. Director's rationale for requesting an LEA-Specific License.
- b. Whether there is an adequate supply of highly qualified and suitable licensed applicants in the license and endorsement area.
- C. Whether it is necessary and appropriate for the Applicant to be in a program to obtain a Professional License.
- 3. A CS Lewis Academy-LEA-Specific License is valid for up to three years, subject to demonstration of adequate progress consistent with:
- a. Progress toward a Professional License,
- b. Successfully putting into effect guidance from a Mentor, and
- c. The observations and recommendations of CS Lewis Academy's Director.
- 4. After the term of the Applicant's LEA-Specific license, an Applicant shall obtain a Professional License.
- 5. A CS Lewis Academy-LEA-specific license expires immediately, if CS Lewis Academy does not employ an Applicant.
- 6. The Applicant shall participate in the following Mentoring Program:
- 6.1. CS Lewis Academy shall provide a trained Mentor who:
- a. Holds a professional educator license; and
- b. Has taught successfully for at least 3 years.
- 6.2. A Mentor will help the Applicant meet the Utah Effective Educator Standards established in Rule R277-530 by:

- a. Assisting the educator with a Self-Assessment (SA).
- b. Ensuring that the educator has a Mentor Plan (MP).
- c. Meeting regularly with the educator for coaching observations and feedback.
- d. Documenting those meetings.
- e. Conducting at a Mid-Year Review (MYR).
- f. Debriefing as part of an End-of-Year Review (EOYR).
- 6.3. The Applicant and CS Lewis Academy will jointly develop a Plan to:
- a. Transition from a CS Lewis Academy-LEA-Specific License to a Professional License.
- b. Identify applicable educational, skill, and/or content knowledge requirements for the Applicant to obtain.
- 7. On its website, CS Lewis Academy shall describe how many teachers have an LEA-specific license.
