

WHEREAS, AMERICA IS THE LAND OF FREEDOM, PRESERVED AND PROTECTED WILLINGLY AND FREELY BY CITIZEN SOLDIERS; AND

WHEREAS, MILLIONS WHO HAVE ANSWERED THE CALL TO ARMS HAVE DIED ON THE FIELD OF BATTLE; AND




