**A. Welcome & Roll Call**

The Planning Commission Work Session began at 6:00 p.m. Chair Anderson welcomed everyone to the meeting and stated for the record that all members of the Planning Commission were present except for Commissioner Henstra. Members of the city staff were also present.

**C. Presentations and Reports**

Mr. Cooper presented the Riverdale Land Use Master Plan and the Future Land Use Map as approved by the general plan. The current zones do not match with the future plan. The general plan has to be amended to make any changes to zoning, boundaries, etc. He explained the America First property is more than half zoned for manufacturing. He suggested having a unified zone, such as a mixed-use zone for the entire West Bench area. A mixed-use zone would focus on how the buildings look and work together. Commissioner Poulsen asked if Ogden Airport would influence what could be there. Mr. Cooper said the entire West Bench is in the airport influence area, so there are restrictions on height.

Mr. Cooper explained that he brought this up for the Planning Commission to keep in mind ideas for changes to the future plan and anticipate changes to zones before they are requested by landowners. He asked if the Planning Commission was interested in staff working on changes to zoning and the city boundary.

There was an extension on the subdivision, but not the site plan. Financing changes have contributed to the delay, as the percentage of the project amount banks will loan were reduced. Interest rates have begun to lower, as well as some construction costs.
