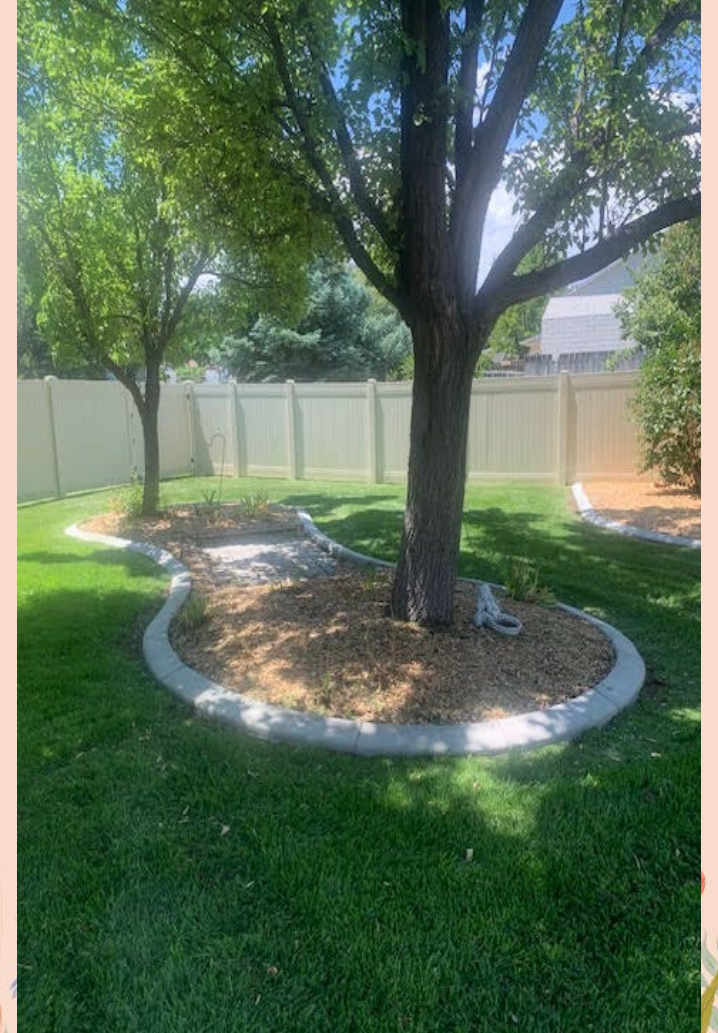
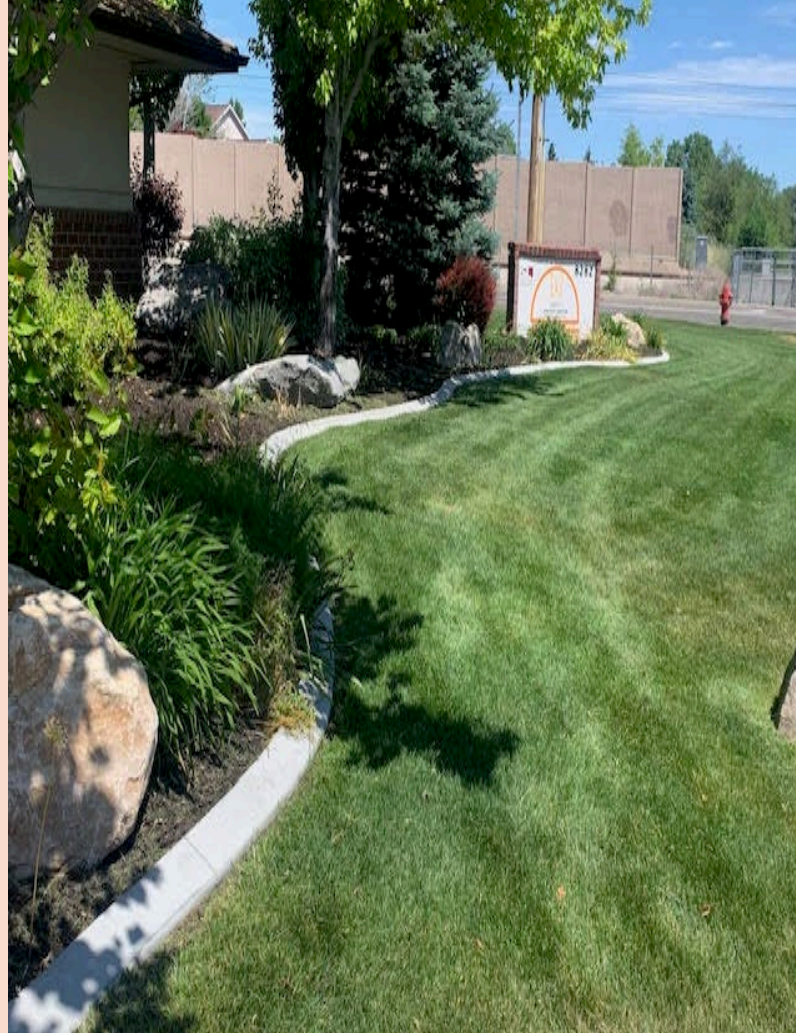


CJC Program – Ryan Woodmansee
