SCOPE OF WORK

Floor

- Protect and preserve existing floor.
- Match and extend floor finish to West Wall after removal of existing cabinets.
- Refinish the entire floor with a new coating of clear coat.

Ceiling

- Demo and remove exist ceiling, light fixtures, and HVAC grilles and registers.
- Demo return air ductwork to points described in attached sketches.
- Demo and remove exist movable wall rail. Allow for installation of new ceiling grid.
- Protect and preserve existing ceiling mounted projector.
- Install new 2'x2' acoustical ceiling grid at existing ceiling height of 110". Match exist ceiling tile, rail, and HVAC grilles and registers in lobby / receptionist area.
- Install new LED light fixtures as described in attached sketches. Provide two motion detectors placed as approved by SVWRF. Wire up step lighting features of fixtures with motion activated occupancy sensors. Two fixtures will be battery backed up for emergency lighting. Rewire lighting fixtures to circuits shown and install one light switch and two 3-way light switches as shown.
- Install four new supply air registers, size and location as shown.
- Install three new return air registers, size and location as shown.

Cabinets

- Demo and remove all existing cabinets.
- Provide all new lower and upper cabinets along West Wall. Proposal should include a draft set of cabinet drawings.
- Provide one lower garbage wall cabinet along East Wall. Include in draft drawings.
- Cabinets shall be Shaker 5-panel door construction with light maple color.
- Indicate all cabinet accessories. Include soft close door hinges and drawer closers. Color to be satin nickel.
- Provide laminate drawer construction.
- Provide Carbon Aggregate Corian countertops.
- Provide Arrowroot Corian Backsplash between upper and lower cabinets.

Walls

- Remove exist crown along walls (dark stained 2x12 wood)
- Prep, refinish and paint all walls with two coates of Sherwin Williams color Modest White to match exist.
- Install dark bronze rubber cove style resilient base 4" high, replacing all existing around room. Mowhawk Group has a color called 099 Black Brown that is acceptable. https://www.mohawkgroup.com/products/accessories/detail/CRW03/Rubber_Cove_120__Roll_4WallBase?cc=002&cn=Night%20Skies&size=4WB

Plumbing

- Provide all plumbing work to accommodate new location of sink, dishwasher and refrigerators, providing drinking water to both refrigerators.
- Provide all plumbing work to eliminate existing drinking fountain and bottle fill station, including both drinking water and drain, waste, vent lines.


Electrical

- Relocate two existing thermostats in use to accommodate new cabinetry. Single abandoned thermostat will be demolished.
- Demolish existing speaker volume knobs and speakers in ceiling. Coordinate demolishing with approval from SVWRF.
- Provide and install new lighting circuits, fixtures and switches as described above along
 with electrical outlets and circuits required to comply with attached sketches for location
 of all appliances and vending machines. Modify existing electrical to sink disposal, oven
 and stovetop, wall mounted microwave, and dishwasher. Provide GFCI circuits to meet
 code as required and provide outlets along backsplash for use on countertops as
 coordinated with Owner.


BEEAK ROOM
