Discussion

Latin Honor System

Liz Moskal, school counselor at PCHS was before the Board to present the Latin Honor System. As part of the realignment committee, they have been looking at changing class ranking. Class ranking was fairly common among high schools but the system is rather outdated, so they would like to update the process. A number of high schools no longer rank or weight classes nor do colleges.

Latin Honor System where students still receive honor for the academic excellence. Less than 50% of high schools nationally are using ranking.

- Rank doesn't accurately represent achievement
- Absence of ranking improves college admissions
- Rank calculations are arbitrary
- Rank encourages hyper-competitiveness and discourages enrollment in non-weighted Classes

Superintendent Huntsman explained that they had originally wanted to move to the Latin Honor System with the realignment, but in hindsight, they feel they will need to do some front loading with families before moving forward.

Superintendent Report-Lyndsay Huntsman presented her monthly report.

On January 22nd, a Schools to Watch (STW) team from Albert R. Lyman Middle School visited EHMS for our fourth redesignation visit, reaffirming the standards of excellence we have upheld since our initial designation in 2013.

As of 2025, Utah has 15 schools recognized as "Schools to Watch" by the National Forum to Accelerate Middle-Grades Reform. These schools have demonstrated excellence in academic achievement, responsiveness to young adolescents' needs, and a commitment to continuous improvement.

Accreditation Engagement Review Report: Park City High School Accreditation and Performance Score: Park City High School received an Index of Education Quality (IEQ) score of 311, which is above the Cognia network average of 296, indicating the school meets accreditation expectations with areas for continued improvement.

March is CTE month and this holds a special place for Superintendent Huntsman. Students now have state of the art facilities for their education. 78% of our students is enrolled in at least one CTE course. Recognized National Counselor Week and thanked all of the hard work of our counselors throughout the district.

As part of our "Road to Realignment" for the Fall of 2025, we'll be making a combination of internal appointments and new hires. We have many talented people within the district, and we would like to give our employees first option if there is interest.

Partnering with families and the community for the general well-being and education of our collective student base while including a culture of inclusiveness and respect for the rich diversity of our community.

It was disheartening to watch HB267, but she and the Board will continue to have an open dialogue with employees.
