#### **ORDINANCE NO. 03-04-2025A**

### AN ORDINANCE AMENDING WEST POINT CITY CODE SECTION 5.25 FIREWORKS SALES AND USE

WHEREAS, the West Point City Council for and on behalf of West Point City, State of Utah (hereinafter referred to as the "City") desires to amend Title 5 Business Licenses and Regulations section 5.25 Fireworks Sales and Use of the West Point City Code; and

WHEREAS, the City Council has duly considered said amendments; and,

WHEREAS, the City Council, after due consideration of said amendments, has concluded that it is in the best interest of the City and the inhabitants thereof that said amendments be adopted;

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF WEST POINT CITY, UTAH as follows:

#### Section One: Adoption of New Provisions

Section 5.25 of the West Point City Code is adopted to read as below: (Strike through text indicates text being removed from the code, and underlined text indicates new additions).

5.25.060 Times for sale of fireworks.

Fireworks may be sold on or between June 20th and July 25th; on or between December 20th and January 2nd; and 15 days before and on the Chinese New Year. during the dates as outlined in Utah State Code 53-7-225 et al.

5.25.070 Times for use of fireworks.

Fireworks may be discharged three days prior to, on the day of, and three days following July 4th, July 24th, January 1st, and the Chinese New Year. during the dates as outlined in Utah State Code 53-7-225 et al.

#### Section Two: ORDINANCES TO CONFORM WITH AMENDMENTS

The West Point City Director of Community Development is hereby authorized and directed to make all necessary changes to the West Point City Code to bring the text into conformity with the changes adopted by this Ordinance.

#### Section Three: Severability

In the event that any provision of this Ordinance is declared invalid for any reason, the remaining provisions shall remain in effect.

#### **Section Four:** Effective Date

This Ordinance shall take effect immediately upon passage and adoption and publication of a summary as required by law.
