**A RESOLUTION APPOINTING A BOARD MEMBER TO THE ADMINISTRATIVE

WHEREAS, the term of Kenton Arbon on the Angell Springs Special Service District Administrative Control Board ("SSD Board") is set to expire at the end of 2027;

WHEREAS, Kenton Arbon resigned from the SSD Board, creating a vacancy;

WHEREAS, a notice of vacancy was advertised pursuant to Utah Code Section 17B-1-304(2);

WHEREAS, Diane Hundal has applied for appointment to the SSD Board;

WHEREAS, staff recommends that Diane Hundal be appointed to serve on the SSD Board to replace Kenton Arbon, with a term to expire on December 31, 2027;
