SUBJECT: Xpress Bill Pay EFT FEES



Background

As you are aware, the District entered into a Gateway and Administrative Service Agreement with Xpress Solution, Inc. (Xpress Bill Pay) in September 2017 to facilitate the collection of service fees for utilities. The District has been covering fees associated with this service instead of passing them on to the account holders responsible for them. These fees include charges for Electronic Funds Transfer (EFT) Returned Items.

Over the past two calendar years, the District has incurred over \$4,500.00 in fees related to Returned Payments, Non-Sufficient Funds (NSF) or Closed Accounts, and Stop Payments. Each year, Xpress Bill Pay sends a letter to the District outlining these fees and any potential increases.

In 2023, the fees were as follows: \$6.00 per transaction for Returned Items, \$12.00 for NSF and Closed Accounts, and \$30.00 for Stop Payment items. In 2024, the prices increased by \$1.00 per transaction, with the exception of the Stop Payment fee, which remained at \$30.00.

Recommendation

The District Recorder has reviewed invoices from Xpress Bill Pay dating from 2023 to the present and believes that the District should bill the EFT Returned Item Fees directly to the account holders.

Staff recommends that the Board approve Resolution 02-2025, which would adopt the Xpress Bill Pay fees in accordance with the 2017 Xpress Solutions, Inc. contract and permit the District to charge these fees to account holders.

RESOLUTION NO. 02-2025

A RESOLUTION OF THE WEST HAVEN SPECIAL SERVICE DISTRICT APPROVING AND ADOPTING THE XPRESS BILL PAY FEES ASSOCIATED WITH THE 2017 XPRESS SOLUTIONS, INC. CONTRACT AND ALLOWING THE DISTRICT TO BILL THOSE FEES TO ACCOUNT HOLDERS; AND PROVIDING FOR AN EFFECTIVE DATE.

Section 1. Recitals:

WHEREAS, West Haven Special Service District ("District") is a quasi-municipal corporation duly organized and existing under the laws of the State of Utah; and

WHEREAS, the District finds that certain sections of Utah Code Annotated 1953, as amended, authorizes public bodies, including the District, to exercise all administrative and legislative powers by resolution; and,

WHEREAS, the District has to bill its account holders every month for services provided by the District; and

WHEREAS, the District needed to provide a way to collect these service fees; and

WHEREAS, in order to be able to collect its service fees, in 2017, the District entered into a Gateway and Administrative Service Agreement with Xpress Solutions, Inc. ("Xpress Bill Pay"); and

WHEREAS, there are different fees that have to be paid to Xpress Bill Pay for different services; and

WHEREAS, the District has been paying those Xpress Bill Pay fees instead of passing them on to the applicable account holder who has incurred those fees; and

WHEREAS, every year, Xpress Bill Pay sends a letter to the District regarding its fees and if there is an increase in those fees, as allowed by contract; and

WHEREAS, at this time, the District needs to adopt those fees, including the EFT Returned Items, and that those fees need to be billed directly to the applicable account holder so that the District is not paying those fees anymore; and

WHEREAS, the District feels that the best way to accomplish the goal of adopting those ongoing fees and billing those fees to the applicable account holders is to adopt this resolution; and

WHEREAS, the District finds that the public convenience and necessity requires the actions herein contemplated; now

THEREFORE, BE IT RESOLVED BY THE DISTRICT BOARD OF DIRECTORS OF WEST HAVEN SPECIAL SERVICE DISTRICT as follows:

Section 2. APPROVE AND ADOPT

- 1. That the District approves and adopts the 2025 Xpress Bill Pay Fees, that is attached as Exhibit A; and that the District approves and adopts any future Xpress Bill Pay Fees, as may be amended by Xpress Bill Pay from time to time and as outlined in the 2017 Xpress Bill Pay contract.
- 2. That the District approves and adopts those fees and future fees, including the EFT Returned Item fees, to be a part of the District's current Fee Schedule so that applicable account holders shall be directly charged those fees.
- 3. The forgoing Recitals are fully incorporated herein.

Section 3. Repealer of Conflicting Enactments:

All orders and resolutions regarding the changes herein enacted and adopted which have heretofore been adopted by the District, or parts thereof, which conflict with any of the provisions of this Resolution, are, for such conflict, repealed, except this repeal shall not be construed to revive any act, order or resolution, or part thereof, heretofore repealed.

Section 4. Prior Resolutions:

The body and substance of any prior Resolutions, together with their specific provisions, where not otherwise in conflict with this Resolution, are reaffirmed and readopted.

Section 5. Savings Clause:

If any provision of this Resolution shall be held or deemed to be or shall be invalid, inoperative, or unenforceable for any reason, such reason shall not render any other provision or provisions hereof invalid, inoperative or unenforceable to any extent whatever, this Resolution being deemed to be the separate independent and severable act of the District Board of Directors of West Haven Special Service District.

Section 6. Date of Effect:

This Resolution, and the changes contemplated, shall become effective on the ____ day of March 2025, and after publication or posting as required by law.

Section 1. Recitals:

WHEREAS, West Haven Special Service District ("District") is a quasi-municipal corporation duly organized and existing under the laws of the State of Utah; and

WHEREAS, the District finds that certain sections of Utah Code Annotated 1953, as amended, authorizes public bodies, including the District, to exercise all administrative and legislative powers by resolution; and,

WHEREAS, since the District was formed, the District has grown and is in need of additional facilities; and

WHEREAS, the District staff has researched and found property within West Haven City which, if purchased, would be a good location for additional facilities and would fit the District's needs; and

WHEREAS, the District has a need to make an offer to the property owners by way of a real estate purchase agreement ("REPC"); and

WHEREAS the District now desires to approve and adopt the REPC and Addendums, attached to this Resolution as Attachment "A", by accepting the terms thereof; and,

WHEREAS, the District finds that the public convenience and necessity requires the actions herein contemplated; now

THEREFORE, BE IT RESOLVED BY THE DISTRICT BOARD OF DIRECTORS OF WEST HAVEN SPECIAL SERVICE DISTRICT AS FOLLOWS:

Section 2. APPROVE AND ADOPT

- 1. That the Real Estate Purchase Agreement and its Addendums, attached as Attachment "A", is hereby approved and adopted by the District Board of Directors.
- 2. That John Wallace, the West Haven Special Service District Sewer Superintendent, is hereby authorized by the District Board of Directors to sign the REPC and its Addendums and any other documents necessary to make an offer to purchase the property.

- 3. That John Wallace is authorized to make any adjustments to the language in the Addendums or any additional Counteroffers to complete the purchase of the property as long as those adjustments do not affect the outlined purchase price in Section 2 of the REPC.
- 4. The foregoing Recitals are fully incorporated herein.
