Distribution of January 26, 2025, Minutes

The minutes for the Council Workshop Meeting held on January 26, 2025, were distributed prior to the meeting.

Division Updates

Patrick Craig reviewed the Division Update sheet that was provided as part of the meeting package. The Utah Department of Environmental Quality – Division of Air Quality (UDEQ-DAQ) is concerned with VOC emissions and the subsequent creation of Ground-Level Ozone formation from compost processes in the Non-Attainment areas of Utah (includes Salt Lake County). UDEQ-DAQ requested information on our compost process and visited the facility to review the current operations. We will continue to track any potential rulemaking associated with this work. Module 8 is now in use, and if any board members would like a tour, please contact Patrick. A summary of the Gas System Upgrades Project will be presented at the next meeting.

Financial Report

Patrick Craig reviewed the January 2025 Financial Report of Expense and Revenues, MSW Report, Compost Report, and Top MSW Customers that are provided as part of the meeting package. The Green Waste Tons report historically provided has been revised to focus on tracking curbside collected material, compost sold, and compost available. Other Green

Waste (previously charged as WOOD COMM) is currently included under the MSW COMM waste code (\$34/ton). **Chris Bell** inquired if the other green waste we accept, not part of the compost process, is currently being tracked. He stated that this information may be useful in the future. The WOOD COMM waste code could be re-activated at the current \$34/ton trash rate, and this would allow this material to be tracked.





Expenses by Expense Type








LANDFILL REVENUE RECEIVED VS EXPECTED
