WHEREAS, MT. PLEASANT CITY ORDINANCE 8-6-10 allows the City Council to evaluate and set fees by resolution; and

WHEREAS, Mt. Pleasant City wishes to adjust cemetery fees to reflect the actual costs incurred by the city, including labor, equipment expenses, and the wages of the Sexton; and

WHEREAS, the cost of labor, equipment maintenance, and cemetery operations has increased, necessitating an adjustment to the fees; and

NOW THEREFORE BE IT RESOLVED by the Mt. Pleasant City Council that the following fees and charges shall be in effect as of the date of approval of this resolution:

BE IT FURTHER RESOLVED that these fees shall be reviewed annually to ensure they continue to reflect actual costs, including adjustments for inflation, labor, and equipment maintenance.

BE IT FURTHER RESOLVED that the resident fee shall apply only to individuals who reside within the city limits of Mt. Pleasant. Those residing in the county with the 84647 zip code shall be subject to non-resident fees. Additionally, individuals who have moved away due to extenuating circumstances but previously lived in Mt. Pleasant for a significant period may be granted resident status for cemetery fee purposes with approval from the Mayor. Employees who have worked for Mt. Pleasant City for five (5) years or more and are not residents shall also qualify for resident pricing.
