The Ute Tribe is closing multiple contracts (see attachment), with the following remaining active:

5. Project Applications

5.a Ute Tribe - Additional Funding - 22-DWS-0288

Request for an additional \$1,380,000, to be distributed equally (\$460,000) to the three bands, for the Tribal Building Rehabilitation Program.

5.b Ute Tribe - Additional Funding - 24-DWS-0516

Request for an additional \$5,373 for the Digital Recording Solutions

5.c Ute Tribe - Additional Funding & Scope of Work change - 24-DWS-0424

Request for an additional \$19,600 to be allocated to 24-DWS-0424 for Coffee Shop Upgrades, as well as a change of scope to include repair/upgrade to filtration system of espresso and ice machine, and repair/upgrade to the Ute Coffee House Trailer (full scope attached).

5.d Ute Tribe - Additional allocation & scope of work change - 21-1106

Request for \$66,800 in additional funding for the 21-1106 (25-DWS-0398) Painted Horse Diabetic Program Building, with a change in the scope of work to include, repair/remediation of various areas of the Painted Horse Building (detail attached).

5.e Ute Tribe - Administration / I.T. Fiber Optic Expansion - \$29,700

\$29,700 requested for the expansion of fiber optic cables. Project entails boring under road from the Ute Tribe Veterans Monument to the Ute Tribe Bottle Hollow recreational camp, as well as from the Ute Plaza Supermarket to the Pow-wow grounds, then placing conduit for fiber optic cables.

5.f Ute Tribe - Cattle Enterprise Vehicle and Equipment Purchases - \$250,728

\$250,728 requested for the purchase of two (2) vehicles equivalent or similar to 2024 Ram 3500 Crew Cab 4x4; two (2) new or similar portable corrals; two (2) new or similar 6'8" x 24' 14k Gooseneck Stock Trailers.

5.g Ute Tribe - Ute Bulletin Equipment - \$14,650

\$14,650 requested for the purchase of a large scale printer, equivalent or similar to an Image Access WideTEK 36F, for the digitization of historic Ute Bulletin newspapers to further preserve Ute history and events for future generations.

5.h Ute Tribe - Air Quality Vehicle Purchase - \$70,000

\$70,000 requested for purchase of a vehicle equivalent or similar to a 2025 Ford F-150 Lariat Truck Super Crew Cap V6 to transport Air Quality staff for emission monitoring and meetings.

5.i Ute Tribe - Additional Allocation - 24-DWS-0515

\$368,000 requested as additional funding for the I.T. Offsite Storage project in 24-DWS-0515.

5.j Ute Tribe - Painted Horse Building Upgrade and Repair - \$70,000

\$70,000 requested for the Painted Horse Building Upgrades and Repair, which includes purchase, design and install of ice melt system for metal roof and repairing outside windows.

1. Welcome & Introductions

Chairman Evan Curtis officially called the Uintah Basin Revitalization Fund (UBRF) Board meeting to order at 3:03 PM, on Thursday, January 16, 2025 via Zoom. Chairman Curtis invited all in attendance to introduce themselves, beginning with board members and followed by others on Zoom. They also welcomed new program staff, Justin Anderson with the Utah Attorney General's Office, and Stephanie Johnson with DWS Finance.

2. Approval of Minutes [3:56]

The draft minutes from the October 24, 2024 meeting were presented. The chair called the question:

Commissioner Miles made, and Commissioner Laursen seconded, a motion to approve the minutes from the UBRF Board meeting held on October 24, 2024. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan, and Chairman Curtis.

3. Fund Report [4:38]

Chairman Curtis invited DWS Finance staff to present the fund balances. Carver Black reviewed the changes to the report format, explaining that it has been updated to reflect the new umbrella contracts. This update is designed to streamline the process and avoid the need for repetitive contracting for each project. He shared the new balance amounts for each entity:

A new column was added to the report showing the amount available in the umbrella contracts, and another column titled "Amendment Available" now reflects the interest earned that can be used to fund projects if necessary.

Chairman Curtis inquired whether board action would be required to add additional funds to the contract. Mr. Black responded that no board action would be needed. Instead, the umbrella contract would simply be amended to increase the amount of available funds. He assured that the existing funds in the contract would be accessible immediately, and any amendment to add additional funds would not cause significant delays to ongoing projects.

4. Board Business [7:12]

4.a Contract Report

Chairman Curtis asked Mr. Moberly to discuss the contract report. Mr. Moberly briefly updated the board, mentioning that two projects had recently been closed out with remaining balances. The first project from Duchenne County had just one penny remaining, essentially spent out. The second project from Uintah County had \$135 remaining, also essentially spent out. Both amounts were reverted back to the unallocated fund.

Laurie Brummond commended Mr. Moberly for his attention to detail. Chairman Curtis praised Mr. Moberly's precise accounting. He acknowledged the high level of accuracy involved in the task and echoed Laurie Brummond's appreciation for the effort.

Chairman Curtis asked if there were any further questions or comments on the contract report. There were none.

4.b Annual Required Trainings (OPMA, GRAMA , Ethics) provided by Justin Anderson [8:36]

Chairman Curtis asked Mr. Anderson to provide the annual required training. Mr. Anderson discussed OPMA, GRAMA, and the ethics statute, including requirements for meeting notices, record-keeping, the importance of transparency, closed meetings, the rules surrounding electronic meetings, and common violations. Chairman Curtis thanked Mr. Anderson for the training and his continued support, as well as Paul and his team for their efforts in ensuring proper meeting notices and minutes.

5. Project Applications [24:35]

5.a Ute Tribe - Renewal of contract 20-1552 [25:00]

Chairman Curtis asked Mr. Moberly to discuss the Ute Tribe renewal contract. Mr. Moberly explained that the contract, which expired at the end of 2024, is straightforward and proposed a one-year extension until 2025. He mentioned that certain parts of the contract, such as the Ute Language Program, might require additional extensions beyond that period.

Hilary Murray clarified that the contract had already been extended for one year during the prior meeting. Chairman Curtis acknowledged the update and confirmed no further action was needed.

5.b Uintah County - Infrastructure Development Phase II - \$1,300,000 [26:58]

Chairman Curtis asked Mr. Moberly to introduce the Uintah County Infrastructure Development, Phase 2. Mr. Moberly explained that this is a continuation of the project approved in a previous meeting for the Lucky Acres affordable housing development, which involves the installation of water, sewer lines, and utilities for 27 self-help homes. Commissioner Larson shared that the project ran out of funds for paving and curbing due to rising costs but emphasized the importance of the development. Laurie Brummond expressed gratitude for the support and discussed challenges in securing affordable lots for the self-help program. Chairman Curtis thanked all involved, and called the question:

Commissioner Miles made, and Commissioner Laursen seconded, a motion to approve the project as presented. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

5.c Ute Tribe - Fund transfer and new allocation to 24-DWS-0523 - \$30,075.20 [31:46]

Chairman Curtis asked Mr. Moberly to introduce the Ute Tribe fund transfer and new allocations. Mr. Moberly explained that the proposal involved transferring funds from 24-DWS-0520 (Drain Jetter) - \$9,924.79 and 20-1110 (Misc community center projects) - \$20,605.21, and allocate \$6,974.80 (difference to \$37,700) in unallocated funding to 24-DWS-0523 (Admin Complex Roof Repair) to cover additional cost overruns and change orders for the Admin complex roof repair project. Mr. Moberly recommended adjusting the motion to transfer up to the remaining balance of both contracts to address discrepancies.

The Chair called the question:

Commissioner Miles made, and Commissioner Laursen seconded, a motion to approve the fund transfer and new allocation up to the requested amount. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

5.d Ute Tribe - Parks & Recreation Vehicle Purchase - \$250,000 [34:39]

Chairman Curtis asked Mr. Moberly to discuss the Ute Tribe parks and recreation vehicle purchase. Mr. Moberly explained that the request was for \$250,000 to purchase three new trucks and equipment for snow removal, including salt spreaders and snowplows. Councilman Duncan added that the trucks were 10-15 years old and had over 200,000 miles but are essential for park and road maintenance. The original department request was for four vehicles, but it was reduced to three.

The Chair called the question:

Commissioner Laursen made, and Commissioner Miles seconded, a motion to approve the project as presented. The motion passed unanimously with affirmative votes from

Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

5.e Ute Tribe - Brownsfield Vehicle Purchase - \$50,000 [36:16]

Chairman Curtis asked Mr. Moberly to discuss the Brownsfield Program vehicle purchase. Mr. Moberly explained that the request was for \$50,000 to purchase a new vehicle for the Brownsfield program, specifically a truck to support the program's activities. Councilman Duncan clarified that this vehicle is needed due to the addition of a new staff member in the Brownsfield Grant department, who will be responsible for identifying hazardous waste sites on the reservation.

The Chair called the question:

Commissioner Miles made, and Commissioner Laursen seconded, a motion to approve the project as presented. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

5.f Ute Tribe - GAP Vehicle Purchase - \$75,000 [37:56]

Chairman Curtis asked Mr. Moberly to discuss the request for a vehicle purchase for the Ute Tribe's General Assistance Program. Mr. Moberly explained that the Ute Tribe was requesting \$75,000 to purchase a new vehicle to support the implementation of a solid and hazardous waste management ordinance, including transportation of waste from temporary community transfer stations to the county landfill. Councilman Duncan confirmed there were no additional comments from the Ute Tribe.

The Chair called the question:

Commissioner Laursen made, and Commissioner Miles seconded, a motion to approve the project as presented. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

5.g Ute Tribe - Recreation Vehicle Purchases - \$150,000 [39:11]

Chairman Curtis asked Mr. Moberly to discuss the request for the Ute Tribe's recreational vehicle purchase. Mr. Moberly explained that the Ute Tribe was requesting \$150,000 for the purchase of two new cargo vans to support the transportation of youth to events, to assist with a running club, and equipment transport. Board member Duncan confirmed there were no additional comments from the Ute Tribe.

The Chair called the question:

Commissioner Laursen made, and Commissioner Miles seconded, a motion to approve the project as presented. The motion passed unanimously with affirmative votes from Commissioner Miles, Commissioner Laursen, Councilman Natchess, Councilman Duncan and Chairman Curtis.

6. Board Member Issues [40:33]

6.a Schedule of Meetings

Chairman Curtis moved on to the discussion of scheduling the next board meeting. Laurie Brummond explained that the meeting could be held at the Ute Tribe's office, and suggested Thursday, April 3rd, as a potential date, due to scheduling conflicts with Mondays and Tuesdays. After confirming availability, the board discussed possible conflicts with other meetings, including the Utah Association of Counties conference. They decided that Thursday, April 10th, at 1:00 PM would work for everyone.

Chairman Curtis entertained a motion to adjourn.

Councilman Duncan made and Commissioner Miles seconded a motion to adjourn the meeting.

The meeting adjourned at 3:48 pm.

Per your email dated February 6, 2025, please accept the following justification letter for the acquisition of a large scale scanner for the Ute Bulletin Department to digitize the old newspapers, photos and documents in our archives.

The Ute Bulletin has been in production since 1959. The first publications were done on a mimeograph machine.

This was a stencil-type process that had the stencil attached to an ink-saturated surface of a hollow, hand rotating cylinder. Paper was fed between the stencil and the roller to create a copy on a standard sheet size of paper. The mimeograph became largely obsolete with the development of photocopiers.

Regretfully there are no known copies of these first issues of the Ute Bulletin. However, in the Ute Bulletin archive we have a 1961 copy of the Ute Bulletin, which was then in its second year of publication, printed on newsprint.

Newspaper, as you are probably aware, was not created to last forever. It is printed on what is called newsprint and is designed to be cheap and readily available. This also means that it breaks down quickly when exposed to light, moisture, and air, causing it to become brittle and discolored over time...the quality of paper is not meant for long term preservation. It is made from inexpensive material that degrades faster than higher quality paper stock. It is also acidic which accelerates deterioration when exposed to the environment. Additionally, even dust can contribute to the breakdown of newspaper.

The condition of these old papers is very delicate. Additionally, until we became digitized in 2015 there are no other means of copying the Ute Bulletin. Their size is approximately 16.5" x 22" and varies slightly as printers have changed.

As time is only progressing the deterioration of these documents I am reaching out to acquire large scale scanner to scan and digitize these important historical documents. I am needing something that has a lid, to apply some pressure to the documents, as they are creased, and the lid will flatten them for a full-contact scan.

I reached out to various Tribal departments (Cultural Rights and Protection, IT, and GIs), with no success. I discussed the matter with Ute Tribe Administration and received their approval to look into scanning options, utilizing Information Technology (IT) Supervisor Colby Clayburn as a resource. Colby reached out to Les Olson (who the Tribe has used for these types of needs). I received a couple of options in response. One is too extremely large (attached) and the other does not have a large enough screen to scan the size we need (attached).

Colby was able to provide another vendor and scanner information that would suit our needs (attached), with the price tag of \$13,650 (quote attached). Our department lacks the funding for such a purchase, but has a great need to get these historically significant papers preserved digitally.

I trust that this information will be of use to you. Please advise should you require additional information from me.

I appreciate your prompt attention in this matter and look forward to hearing back from you.

The Ute Indian Tribe Air Quality Department is developing a project focused on leak detection and repair (LDAR) program as a part of a larger air quality initiative focused on mitigating methane and other harmful air pollution emissions in the oil & gas industry that secure major climate and health benefits for all communities on the Uintah & Ouray Reservation. This initiative aims to enhance environmental monitoring using an infrared optical gas imaging (OGI) camera to ensure compliance with air quality standards through effective identification of fugitive emissions for oil & gas sources. The project underscores the department's commitment to maintaining air quality and safeguarding public health within the community.

The Ute Indian Tribe Air Quality Department comes to request the assistance of the Ute Indian Tribe's Revitalization Department to purchase a 2025 Ford F-150 Lariat Truck SuperCrew CabV6 to transport air quality staff to meetings with industry stakeholders and also to conduct optical gas imaging surveys on oil & gas sources on the Uintah & Ouray Reservation. There are over 9,000 emission sources on the Uintah & Ouray Reservation. The vehicle will allow the air quality staff to commute to oil & gas locations to conduct optical gas imaging surveys. The US EPA has finalized requirements for optical gas imaging camera operators where senior operators will need to log up to 1,400 survey hours to become a "Senior OGI Camera Operator". This is a goal that we are striving to meet, as a Senior OGI Camera Operator will be able to assist in the training of new camera operators in the future. When the Leak Detection and Repair Program is fully operational it will be an effective program that assists the oil & gas industry in finding fugitive emissions, and will be a source of revenue that will supplement the Ute Indian Tribe and the Air Quality Department.
