Resolution 2025-02

A resolution of the Wayne County Commission to Authorize the Imposition of a 0.30% Local Option Sales and Use Tax to Fund Public Safety

WHEREAS, Wayne County is authorized to impose a local option sales and use tax to fund public safety under UTAH CODE SECTION 59-12-2216 (2024); and

WHEREAS, the Wayne County Commission finds that there is an ongoing and special need to better fund public safety in the county; and

WHEREAS, the Wayne County Commission finds that the imposition of this local sales and use tax would be in the best interests of and promote the health, safety and general welfare of the residents of Wayne County;

NOW, THEREFORE, the Wayne County Commission resolves as follows:

- 1. The Commission approves the imposition of a three-tenths of one percent (0.3%) sales and use tax within Wayne County as set out in UTAH CODE SECTION 59-12-2216. This county option sales tax will apply to all transactions described in Utah Code §59-12-103(1) within the county, including within the cities and towns in the county.
- 2. One hundred percent of these sales and use tax revenues will be allocated to fund public safety purposes.
- 3. The intention of the Commission is for this resolution to be sent to the Utah State Tax Commission to have the tax commission apply this tax as soon as allowed by UTAH CODE SECTION 59-12-2209.
