RESOLUTION R2025-B

A RESOLUTION ENACTING THE THIRD QUARTERLY AMENDMENT OF THE ADOPTED BUDGET OF VIRGIN TOWN FOR FISCAL YEAR 2024-2025

WHEREAS, the Town Council of Virgin Town has adopted Resolution R2024-L which adopted the final budget for the fiscal year beginning July 1, 2024 and ending June 30, 2025, in accordance with the requirements of the Utah Code Annotated; and

WHEREAS, the Town Council of Virgin Town wishes to amend the fiscal year 2024-2025 budget; and

WHEREAS, a public hearing to consider the appropriations has been noticed and held on April 15, 2025 and all interested persons were heard, for or against the appropriations; and

WHEREAS, the Town Council of Virgin Town hereby finds this action in the best interest of the public's health, safety and general welfare.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF VIRGIN TOWN, STATE OF UTAH AS FOLLOWS:

Section 1. Purpose. The purpose of this Resolution is to amend the budget of Virgin Town, as approved and finalized by Virgin Town Resolution No. R2024-L.

Section 2. Authorization. The Mayor is authorized to sign any agreements to implement the budget amendments adopted by this Resolution.

Section 3. Adoption of Amendments. The budget amendments attached hereto and made a part of this Resolution shall be, and the same hereby are adopted and incorporated into the budget of Virgin Town, Utah for the fiscal year beginning July 1, 2024 and ending June 30, 2025, in accordance with the requirements of the Utah Code Annotated.

Section 4. Filing of copies of the Budget Amendments. The Budget Officer is authorized and directed to certify and file a copy of said budget amendments in the office of the Town Recorder which amendments shall be available for public inspection.

Section 5. Severability. If any section, part, or provision of this Resolution is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts, and provisions of this Resolution shall be severable.

Section 6. **Effective Date.** This Resolution shall become effective immediately upon its passage.
