Staff Recommendations:

1. Approval of the FY26 HSCM Application Narrative Questions (Appendix A)

Approve the FY26 HSCM application, as outlined in Appendix A. OHS will incorporate feedback into the final submission.

2. Adoption of Performance Measures (Appendix B)

Adopt a set of performance measures, as outlined in Appendix B. OHS will incorporate these measures in the FY26 application and upcoming fiscal year contracts.

3. Adoption of HSCM Framework for Public Safety Funding (Appendix C)

Adopt an Eligible Expenses Framework for the use of funding allocated to municipalities.

Summary:

- Tier 1 and 2 eligible municipalities must submit an application for funding, and present a request for account funds ([Utah Code 35A-16-403](#)). OHS has prepared the narrative portion of the FY26 HSCM application for review, feedback, and approval. The FY26 HSCM application includes updates to performance measures, eligible expense guidance, and questions in alignment with the 2025 General Legislative Session.
- The total available funds for FY26 HSCM is not yet available. The Utah State Tax Commission will provide funding amounts within the next month.
- Presentations to request funding will take place during the June 19, 2025 UHSB Meeting.
