**Maintenance Dept: Scott Gordon** reported that they have been busy servicing trucks, getting the mower ready and working at the Rodeo grounds. Helped Cleveland City dig a grave.

**Animal Control: Robert Baker** explained that there was an unusual situation with a dog and who actually owned the dog. There will be no more warnings, tickets will be issued for roaming dogs.

**Council member Kay** reported that Planning & Zoning is reviewing the Mobile Home and Mobile Home Park ordinance. At the Fire Station, one fire fighter is going to Wild Land training in Green River. Thanked employees for putting in air line at Fire Station. Three community Service Workers, have been cleaning lawns, cleaning at the Harts Ball Park and painting the horse stalls at the Rodeo Grounds. **Council member Miller** reported that August 2<sup>nd</sup> will be the District Riding Club meet. Employees have helped on the arena dirt improvements. Diamond H Rodeo Contract is expired so there will be an advertisement in the paper to get bids. A fee schedule for the arena is in the works. **Council member D Wilson** told of a compliment from someone who attended a burial; the compliment said how nice and clean the cemetery was

kept in the winter. Trails were made in the snow to make it easy to the grave site. **Council member Beagley** thanked employees for doing the Harts ball fields, a new catcher's plate has been ordered. A Parks and Recreation Grant was submitted to the DNR to see if they can help us put in a pickle ball court. The audit committee is able to look at receipts and money movement, it is also good for the Council to review. **Council member G Wilson** explained that we have a new Easter Bunny costume and the easter egg candy has arrived. YCC will be filling candy bags at 4:30 on the 16<sup>th</sup>.
