BOARD OF EQUALIZATION/EXEMPTION HEARING

A Board of Equalization Hearing was called to order by Commissioner Victor Iverson at 3:00 p.m. on April 15, 2025, in the Commission Chambers, Washington County, Administration Building, St. George, Utah. Those in attendance were Commissioner Victor Iverson, Commissioner Adam Snow, Commissioner Gil Almquist, Deputy County Attorney Steven Scott, County Clerk/Auditor Ryan Sullivan, representing the Clerk of the Board, Camille Hastings and Deputy County Clerk Sarah Lloyd.

APPROVAL OF MINUTES OF OCTOBER 1, 2024

MOTION: Motion by Commissioner Snow to Approve the Board of Equalization Minutes of October 1, 2024. Motion seconded by Commissioner Almquist and carried by a unanimous vote, with Commissioners Iverson, Snow and Almquist voting aye.

CONSIDERATION OF PROPERTY TAX EXEMPTIONS

Clerk/Auditor Ryan Sullivan explained that the Board of Equalization was convening for the purpose of considering the 2025 requests for exemptions of both real and personal property. Properties are either exempt by virtue of their ownership or their use (religious, educational, or charitable). The use must be exclusively for religious, charitable or educational purposes. The burden of proof rests with the property owner requesting exemption. Mr. Sullivan explained there were two applications that were denied. One property is owned by the Dove Center and is vacant land. The other property that was recommended for denial is owned by the Hope Pregnancy Center, and is unoccupied and has been listed for sale since the end of 2024.
