**Chris Trusty moved to approve the MPO TAC meeting minutes from January 8, 2024.**  
**Brad Kenison seconded the motion. The motion passed unanimously.**

[TIP Selection Process, Project Ideas and Study Approval Bob Allen, MAG \(1:52\)](#)

MAG is continuing the 2024 TIP selection process that began last year and will be completed in August. For the Project Idea Phase of the process, 50 projects were submitted with a total draft cost estimate of over \$250M. On December 4th, MPO TAC met to review and give feedback for each project, and MAG staff reviewed and rated each project based on the adopted selection criteria. The purpose of this phase is to help projects determine whether to continue with the process. No feedback or rating precludes a project from moving to the Concept Phase

Studies submitted through this process do not need to continue into the Concept Phase. The following studies are requesting to be funded.

Orem requested funds to update their Active Transportation Master Plan. MAG's policy has been to fund an initial active transportation plan but allow each community to maintain and update that plan.

Jill Spencer asked how studies scheduled to begin this year are funded. Bob Allen explained that MAG is conservative when it allocates projected funds to TIP projects. When revenue exceeds projections, it creates potential gaps in funding to cover the cost of studies. Money that is left over is used for the following selection process.

**Jason Bond moved to recommend that the five studies be funded as presented. Vern Keeslar seconded the motion. The motion passed unanimously.**

MPO TAC members were reminded that draft concept reports are due February 12. MAG is also asking that a draft copy of the UDOT cost estimate spreadsheet be provided. A link to the latest version of the cost estimate sheet is in Workflow under the cost estimating section. The sponsor concept report review with MAG will happen in the last week of February. Final concept reports are due March 11.

**Transportation Improvement Program (TIP) Modification** *Bob Allen, MAG*

**Santaquin Main Street** [\(11:17\)](#)

Santaquin was awarded two separate phases of a project to widen Main Street from 3 lanes to 5 lanes. Phase 4 was awarded \$4,450,000 to widen from 300 E to 100 W in 2018. Phase 5 was awarded \$5,270,000 in 2020 to extend from 100 W to 600 W and complete the project. In an effort to reduce costs and construction impacts, Santaquin has combined the two phases into one project.

The project is fully designed and initially went out to bid with only one response totaling over \$20m. Since that time, Santaquin went out to bid again with better results.

Construction inflation raised the total cost to \$17,726,127 and is requesting additional funds be added to the project. UDOT has already added \$753,000 to aid with signal work and pavement preservation.

**Brad Kenison moved to recommend that the requested funds be added to the project. Ben Hunter seconded the motion. The motion passed unanimously.**

***Eagle Mountain Airport RD (24:54)***

In 2022, Airport Road in Eagle Mountain was awarded county transportation tax funds to construct a new two-lane connection between SR73 and Eagle Mountain Town Center near Cedar Valley High School. This new project would add a new connection in a congested area.

As the project was designed, it was determined that the intersection of SR73 needed to be modified to meet safety standards. In addition, cost estimates show additional funds are needed to cover construction inflation. Since the project was selected, a new school has been announced on the north side of the intersection. Eagle Mountain is requesting additional funds as well as a scope addition to accommodate the connection on the north side of SR73.

**Vern Keeslar moved to recommend that the Eagle Mountain Airport Rd project scope be modified as presented with the addition of \$2,779,487. Jason Bond seconded the motion. The motion passed unanimously.**

[UDOT R3 - I-15; Springville/Spanish Fork Interchange - Scope & Funding Addition](#)

In 2022 the Transportation Commission funded the interchange at 1600 S in Springville. It is ready to go to bid and needs an additional \$52.6M. The project will begin construction in March 2024.

ROW increased by \$23.5M

Utility costs have increased by \$4M.

Construction Costs \$17M, including increases in the following items:

Lightweight Aggregate \$1.2M

Drainage up \$4M

Noise walls \$750K

Aesthetics \$300K

Mob \$4M & TC \$2.3M

Current Project Value: \$79,912,823
