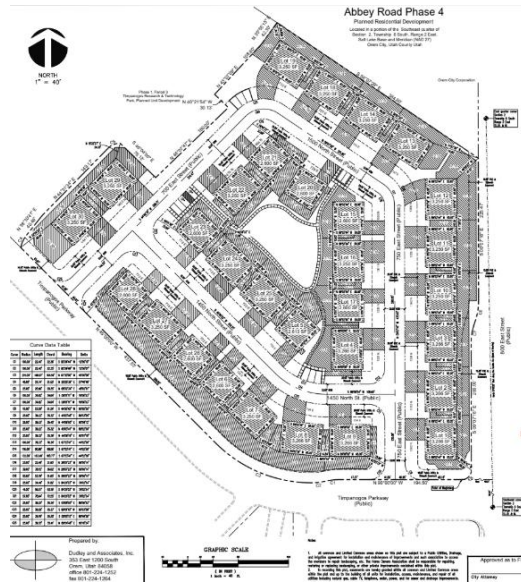
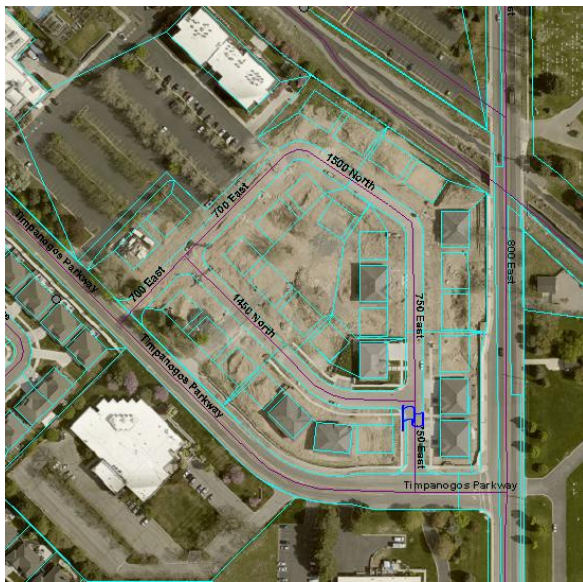
11:02 a.m. Jared Hall called the meeting to order.

1. Plat Amendment Approval – Abbey Road Phase 4 – located generally at 1450 N. 750 East – Approved

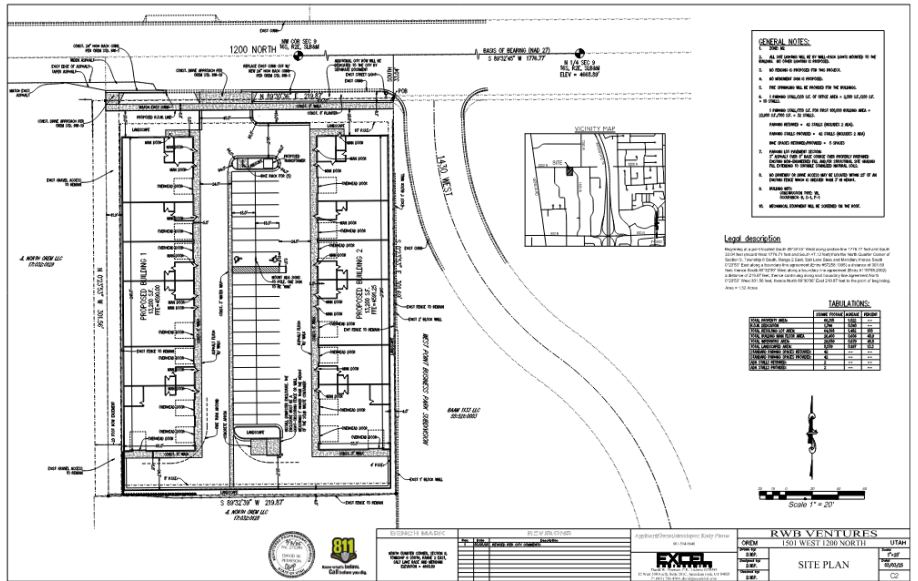

2. Site Plan Approval – RWB Ventures – located generally at 1492 W. 1200 North – Approved

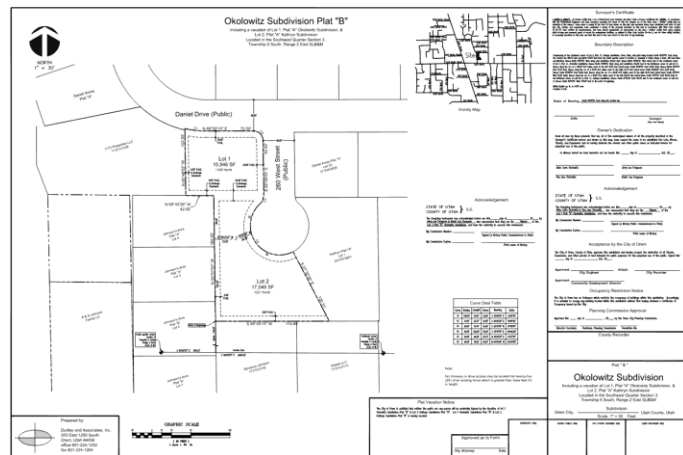
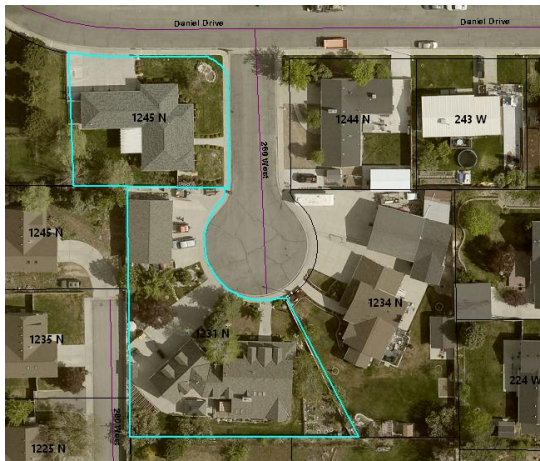
