- Director Report

Kelly Simonsen reported on 2025-2026 enrollment data. There are 390 students enrolled for the upcoming year. Professional development goal is to maintain success criteria growth. Kelly Simonsen clarified the learning intentions, rationale, and success criteria aspects of the professional development being coordinated by the state. There are many performances happening the school; they just wrapped up a 5th grade program called "Annie for Kids". Field day is May 22nd.

- Finance Report

Dawn Benke reported that local revenue is high at 83 percent of the way through the year. State revenue is higher than where it should be, due to new programs. Federal revenue is low but there will be reimbursements coming in that will balance it out. Overall, the LEA's budget is in a good position.
