

Laura Bishop applied to Install Fiber in a portion of Orem City generally around 520 S Geneva Road. All comments during the DRC review have been met.





Kelsey McKay applied to Install Fiber in a portion of Orem City generally around 415 W 800 South. All comments during the DRC review have been met.





Kelsey McKay applied to Install Fiber in a portion of Orem City generally around 316 S 150 West. All comments during the DRC review have been met.





Laura Bishop applied to Install Fiber in a portion of Orem City generally around 672 S 200 West. All comments during the DRC review have been met.






