We know we could drop some but we have growth potential

14 new intents in the lottery

enrollment looks good

10+% not returning in years past this year we are at 7%

4-8% trickle off over the summer

we have 3% of current students undecided about return

5 grades full enrollment, 68 students enrolled in kindergarten with a waitlist

interactions.

Visuals 3 posters for compliance, known routines-verbal cues, precision commands, think sheets.

Consistent language

I do posters- take care of self, take care of space, take care of us

Use examples to set class norms autonomy and flexibility for the teacher.

5 steps for compliance

We are prepared for an uptick in behavior due to the structures. Teacher action steps and cued responses. Fidelity checks in the classroom.

Buy-in across the grades and commitment from all teachers

Jodi- concerned that the expectations are not being met in all spaces, specific questions were asked. Talk about training parents how to communicate about concerns and how the information is responded to by teachers and admin.

clarification about skipping steps in the compliance chart and fidelity checks concern about public humiliation, clarification given about how the needs of the student visiting the office are being met.

The BCBA has been very blunt and clear about what is happening within the school and how to make the changes
