<u>Public Hearing – May/Coleman Rezone from RR to R-1 – Parcels 04-026-0033, 04-026-0032, 04-026-0054.</u>

A. Open Public Hearing: 7:04 p.m.

STACI ZILLES-NELSON motioned to Open the May/Coleman Rezone Hearing at 7:04 p.m. KELLI SHAW seconded the motion. MOTION CARRIED with Bob Kosbab for, Anna Dammer for, Kelli Shaw for, Staci Zilles-Nelson for and Jacob Jaques for.

Kenny F explained that Frank May is purchasing a parcel from his neighbor; by doing this it will make the frontage non-conforming for one of the parcels. Rezoning the parcels will make it so that the frontage requirements are met. Frank is also cleaning up some of the lot lines to make it cleaner and more straight forward. Staci Z-N and Kelli S both expressed that they liked the presented plan. Frank M clarified that he's been taking care of this parcel for years and is now able to purchase it from the landowners.

Bob K asked that the Commission to look at the proposed rezone to see if this fits the intent of the City. Laurie H expressed that she felt this was the area where they could have more density. Staci Z-N asked if this was similar to a previous request made that the commission turned down. It was clarified that the previous rezone was turned down. Bob K felt that RR does not fit the intent. He stated that along the highway has the smaller lots, however off the highway has larger parcels.

- B. Manure: Laurie H stated that the city has an issue with the accumulation of manure and there is not a defined way of how to deal with manure. Some suggestions made included different regulations for different lot sizes. Laurie H feels that smaller lot sizes need to make sure the manure is removed from their property so that it does not accumulate. They will need to address an accumulation definition. Also, what constitutes manure? David H stated that currently manure regulations are the same in an ag zone as it is in a residential zone. There was further discussion about requirements for zoning vs density of housing surrounding large accumulation of manure.
