Uintah Water Conservancy District (Owner) is requesting Bids for the construction of the following Project: Red Wash Feeder Canal Rehabilitation.

Bids for the construction of the Project will be received at Jones & DeMille Engineering located at 520 West Highway 40, Roosevelt, UT 84066, until Friday, June 27, 2025 at 10:00 A.M. local time. The Project includes the following Work: construction of new concrete intake structure, installation of approximately 4,785 linear feet of Owner supplied HDPE pipe, connecting to existing HDPE pipe, and incidental work. Bids will be received for a single contract.

Owner anticipates that the Project's total bid price will be approximately \$459,000. The Project is expected to be completed by October 31, 2025.
