General Notice:

Uintah Water Conservancy District (Owner) is requesting Bids for the construction of the following Project: Whiterocks Canal Diversion Structure

Bids for the construction of the Project will be received at the office of Jones & DeMille Engineering, Inc. located at 520 West Hwy 40 Roosevelt Utah, 84066, until Friday, June 27, 2025 at 10:00 A.M local time. At that time, the Bids received will be publicly opened and read. Bid results will be posted on the State Purchasing website, Bonfire, at <https://utah.bonfirehub.com/projects>.

The Project includes the following Work: Constructing a new concrete diversion structure on the Whiterocks River to divert irrigation and culinary water into the Whiterocks Canal, dewatering, installation of approximately 105 cubic yards of reinforced concrete, installation of owner supplied radial gates and slide gates, concrete flume replacement, riprap bank protection, telemetry, and associated work. Bids will be received for a single contract.

The Project has an expected duration of 60 days and is expected to be completed by March 31, 2026.
