LEGISLATION ANNOUNCEMENTS JARED BROWN

The Office will be sending a communication regarding <u>HB152</u> (establishes requirements for certain satellite emergency departments; and limits the number of satellite emergency departments that a health care organization may operate) and <u>HB146</u> (repeals the women's cancer screening notification requirement under state law) to applicable providers (Hospitals, Emergency Departments and Mammography centers).

- R432-45 Nurse Aide Training and Competency Evaluation (effective May 8)
- R₃80-600 General Provisions Enforcement (effective May 8)
- R432-270 Assisted Living (change in proposed rule to update content for 380-600 specifically critical incident reporting-will be in May 15 bulletin)

Rules for Legislative Compliance

- R432-950 Mammography to comply with HB146 (aligns with change to statute 21 CFR 900 Subpart B code of federal regulations governing mammography standards and recently simplified notifications for dense breast tissue)
- R432-100 General Hospital Standards to comply with HB152 (simple addition to outline conditions for operating an satellite emergency dept)
- Upcoming: R432-31 Order for Life Sustaining Treatment for SB0134 that will go into effect in January-we will provide this in the next committee meeting.

Construction Rules

- R432-4 General Construction was activated as previously amended on March 15.
- New 432-4 was drafted to add back incorporations by reference and standardize duplicative construction rule content into one place that applies to all (except Assisted Living).
- Plan is for OL to work with Michael Dolan (construction representative) and file asap. With the <u>12 construction rules</u> aligned to follow as soon thereafter as possible. No substantive changes, just moving content and restructuring for rulewriting manual compliance.
- *A special meeting will be called in coming weeks to assemble a quorum and recap this content for a vote to advance these rules for filing, since it wasn't on the agenda 24 hours before the meeting.

R432-35 BACKGROUND CHECK-HEALTH FACILITES LICENSING DAPHNE LYNCH

Daphne and Kami presented R432-35 amendments to address the recodification and retilling of the Utah Criminal Code. Additional amendment included the 2-year denial timeframe to include date of completion of the administrative hearing.
