## A RESOLUTION OF THE CITY OF TAYLORSVILLE RE-APPOINTING DAVID YOUNG AS AN ALTERNATE FOR DISTRICT 1 TO THE PLANNING COMMISSION.

**WHEREAS**, the Taylorsville City Council (the "Council") met in regular session on June 4, 2025, to consider, among other things, re-appointing David Young as an alternate for District 1 to the Planning Commission; and

WHEREAS, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(a) directs that members of the City's Planning Commission are to be appointed by the City Council, including one (1) alternate member; and

WHEREAS, David Young has been serving as the alternate to the Planning Commission; and

WHEREAS, David Young's current term as alternate is about to expire; and

**WHEREAS**, the City desires to re-appoint David Young as an alternate for District 1 to the Planning Commission for an additional term expiring on June 30, 2028; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the City's citizens to re-appoint David Young as alternate to the Planning Commission for an additional term.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that David Young is hereby re-appointed as an alternate for District 1 to the Planning Commission for an additional term.

This Resolution, assigned Resolution No. 25-14, shall take effect immediately upon passage and acceptance as provided herein.
