**A RESOLUTION OF THE CITY OF TAYLORSVILLE RE-APPOINTING DON  
RUSSELL TO THE PLANNING COMMISSION AS AN AT-LARGE  
REPRESENTATIVE FOR DISTRICT 5.**

**WHEREAS**, the Taylorsville City Council (the “Council”) met in regular session on June 4, 2025, to consider, among other things, re-appointing Don Russell to the Planning Commission as an at-large representative for District 5; and

**WHEREAS**, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(a) directs that members of the City’s Planning Commission are to be appointed by the City Council; and

**WHEREAS**, TAYLORSVILLE MUNICIPAL CODE §13.03.030(A)(2)(b) states that Planning Commission members serve a four-year term; and

**WHEREAS**, Don Russell has been serving on the Planning Commission for the previous four years; and

**WHEREAS**, Don Russell’s current term as a Planning Commission member expires soon; and

**WHEREAS**, the City desires to re-appoint Don Russell to the Planning Commission as an at-large representative for District 5 for an additional term expiring on June 30, 2028; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the City’s citizens to re-appoint Don Russell to the Planning Commission for an additional term.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that Don Russell is hereby re-appointed to the Planning Commission as an at-large representative for District 5 for an additional term.

This Resolution, assigned Resolution No. 25-15, shall take effect immediately upon passage and acceptance as provided herein.
