



Taylorsville Citations Fourth Quarter 2014







Investigations Unit

- On 7/1/14, Detective Miller culminated a joint NSC and Utah Co Major Crimes Unit investigation in SLC, Utah by writing and executing a drug search warrant. 31 grams of methamphetamine, 49 grams of heroin, 3 handguns and nearly \$2,000 in cash were seized.
- On 7/2/14, Detectives Ikemiyashiro and Lloyd conducted a knock and talk at Calloway Apartments. A resident came to the door with methamphetamine in his hand. He was arrested and a search warrant was written and served. Methamphetamine, drug paraphernalia, and suboxone pills were seized. The tenants were evicted by management.
- On 7/3/14, Detective Fowler located an occupied stolen vehicle and followed it until additional support units could arrive. The vehicle was "boxed in" and the driver was taken into custody.
- On 7/8/14, NSC Detectives and Chief Wyant assisted the Metro Gang Unit on the arrest of a fugitive at a Taylorsville apartment complex. The fugitive was stopped in a vehicle leaving the complex and was arrested. A second adult male in the car was uncooperative and was forcibly taken into custody. He was wearing a pistol holster and a handgun was located behind his seat. He was also found in possession of methamphetamine and drug paraphernalia.
- On 7/8/14, Detective Fowler located an unoccupied stolen vehicle in a Taylorsville neighborhood. It had been stolen from a Taylorsville resident a couple days prior.

- On 7/8/14, Detective Fowler located a stolen motorcycle in a Murray hotel parking lot. Additional resources were summoned and surveillance was held on the motorcycle. As a male was getting on the motorcycle, units converged but the suspect was able to maneuver around them and flee at a high rate of speed. The rider missed his turn and abandoned the motorcycle. UPD K9 Officer Lovato's service dog located the suspect hiding nearby.
- On 7/9/14, Detective Miller and Officer Chacon received information from SLCPD that a stolen enclosed trailer containing an expensive racing truck profiled by the media was at a mobile home community in Taylorsville. They recovered the vehicles.
- On 7/9/14, Detective Miller observed a vehicle in Taylorsville occupied by a wanted fugitive. A traffic stop was conducted. The fugitive was arrested. Methamphetamine, stolen credit cards, fraudulent checks, and other stolen documents were located and seized.
- On 7/11/14, Patrol Officer's responded to a Taylorsville apartment on an allegation that a prostitute had been held against her will and assaulted by her pimp. While clearing the residence, a small amount of marijuana was observed. Detective Ikemiyashiro wrote a search warrant for the apartment and cell phones. Charges were filed for aggravated exploitation of prostitution. The pimp was booked into jail.
- On 7/14/14, Detective Miller developed information regarding an occupied stolen vehicle. The vehicle was located and "boxed" to prevent a pursuit. The driver was arrested for possessing the stolen vehicle and was also in possession of methamphetamine. He was interviewed and disclosed the location of another stolen car at a house in Kearns. Detectives contacted the residents and located a stolen Nissan Maxima in the garage.

- On 7/15/14, Detective Ikemiyashiro located a stolen motorcycle at Calloway Apartments. Detectives observed suspicious activity occurring at a nearby apartment. Contact was made at the apartment. A parole fugitive was located inside, resisted arrest and was forcibly taken into custody. While a search warrant was being written, another parole fugitive walked up to the apartment and was arrested. A quantity of methamphetamine, forgery related documents, packaging material, drug paraphernalia, and shaved keys were located and seized.
- On 7/17/2014, Taylorville DEU & NSC Detectives assisted the Metro Gang Unit and ATF in the service of two search warrants. 2 ½ lbs of methamphetamine, ¼ lb of heroin, 2 lbs of marijuana, and \$13,000 in cash were seized.
- On 7/21/2014, Detective Lloyd observed a female using drugs inside of a vehicle. He attempted to make a traffic stop but the driver failed to yield. Detective Ikemiyashiro “boxed” the car. The two occupants were taken into custody. The male was found to be in possession of over 4 grams of heroin and was booked. Criminal charges were screened against the female.
- On 7/25/2014, Detective Miller observed a vehicle associated with a federal fugitive parked next to an open storage unit. He located her inside and she was booked into jail.

- On 8/4/14, Detective Ikemiyashiro observed suspicious activity involving three men in a business parking lot. Based upon her observations, she believed that the individuals were in the process of committing a vehicle burglary and detained them. One of the males was a wanted parole fugitive and another was found in possession of drug paraphernalia.
- From 8/5/14 to 8/8/14, Taylorsville Investigations Unit detectives participated in a 4 day multijurisdictional auto theft and proactive enforcement operation. Several occupied and unoccupied stolen vehicles were recovered. Additionally, several drug arrests were made and stolen property recovered.
- On 8/5/14, Detective Miller obtained the possible location of two federal fugitives, who were listed as armed and dangerous. A coordinated arrest plan was developed and Officers contained the residence while others made contact at the front door. Detectives entered and located one of the fugitives. The other fugitive was found hiding inside of the residence. An adult female was discovered to be providing false personal information. Detectives determined that she was also a wanted fugitive with several outstanding felony warrants. All three were booked into jail.
- On 8/5/14, Detective Lloyd located a male with an outstanding arrest warrant at a nuisance house, 5580 S. Lolene Way. When other Detectives arrived to assist, the male had gone inside. Detectives established a containment perimeter and the occupants of the residence were contacted and exited. The wanted party was arrested and was determined to be in possession of a stolen Ford Mustang parked in the driveway.

- On 8/5/14, Detective Lloyd conducted a traffic stop on a suspicious vehicle. The occupants were found to be members of a street gang. A passenger in the vehicle had a large butcher knife concealed in his pants and resisted arrest. He was forcibly detained causing a minor injury to his chin. A loaded .45 caliber pistol was located under a seat.
- On 8/6/14, Detective Ikemiyashiro located a wanted male adult. Incident to arrest, he was found to be in possession of ½ ounce of marijuana.
- On 8/14/14, Detective Muniz and other Detectives went to a residence regarding a previous case. While there, Detective Muniz was able to identify a male parole fugitive. The male was arrested and booked into jail.
- Detective Fowler and Officer Bushnell attended the Utah Narcotic Officers Association (UNOA) conference in Mesquite, Nevada. Detective Brett Miller and Chief Wyant were each presented with a Citation of Honor at the UNOA awards banquet.
- On 8/18/2014, Detectives Lloyd and Ikemiyashiro received intelligence info that a wanted fugitive was at an address in Millcreek. They located and arrested the fugitive. He was found in possession of 2.1 grams of methamphetamine and documents used to commit fraud and forgery.
- On 8/21/2014, Taylorsville DEU and NSC Detectives assisted Detective Morton on a search warrant service at Calloway Apartments. 49 grams of methamphetamine and nearly \$1,000 was located and seized. Four adults were arrested and evictions were secured.

- On 8/21/2014, Detective Fowler conducted a traffic stop. During the stop, he was able to develop probable cause that drugs were in the vehicle. He searched it and located 2 ½ ounces of methamphetamine, 28 grams of heroin, and approximately \$4,000 in cash.
- On 8/25/14, Taylorsville Investigations Unit Detectives assisted in a prostitution/vice sting in Midvale. Five females were arrested for prostitution.
- On 8/27/14, Detectives Ikemiyashiro and Lloyd conducted a “knock & talk” investigation at Casa Linda Apartments. Upon closer examination, Detectives discovered that the vehicle was listed on NCIC as stolen. Two adult females were arrested. Methamphetamine, stolen checks and drug paraphernalia were found in the vehicle.
- On 8/27/14, Detectives Lloyd and Ikemiyashiro arrested three adults for active arrest warrants. Detective Ikemiyashiro obtained a search warrant which resulted in the seizure of a 12 gauge shotgun.
- On 8/28/14, Patrol Officers responded to Extended Stay Motel on a complaint of a strong smell of marijuana. Officers arrived and observed several pounds of packaged marijuana on the bed. Taylorsville Investigations Unit Detectives responded and obtained a search warrant. Approximately 30 lbs of high quality marijuana was located and seized. The suspect was booked into Jail on distribution charges.

- On 8/28/14, Detective Fowler located a stolen vehicle at Casa Linda Apartments. A second vehicle pulled up next to it and removed items from it. Detectives performed a traffic stop and the driver fled on foot. He was apprehended and booked into jail. Two other adults were also arrested.
- On 9/2/2014, Detective Ikemiyashiro located an occupied stolen vehicle. She requested assistance and was able to take the adult male driver into custody. He was booked into jail.
- On 9/4/2014, Detective Miller was able to obtain knock and announce search warrants for two separate residences. Forced entry was made into both locations. 12 ounces of methamphetamine, 3 handguns, marijuana, and nearly \$7,000 was located and seized.
- On 9/5/2014, Taylorsville Investigations Unit Detectives assisted the Midvale Investigations Unit in arresting an adult male who had 5 pounds of marijuana in his possession.
- On 9/5/2014, Detective Miller conducted a traffic stop of a suspicious vehicle. Both occupants of the car had active felony warrants. Both were booked into jail.
- On 9/9/14, Detective Miller obtained a knock and announce drug search warrant for a residence in West Valley City. Taylorsville Investigations Unit Detectives served the search warrant without incident. One male adult was arrested for an active arrest warrant. Six firearms (one listed as stolen on NCIC), methamphetamine, marijuana and LSD were located and seized.

- On 9/10/14, Detective Ikemiyashiro obtained a knock and announce drug search warrant for a residence in Taylorsville. The search warrant was served and two adult females were arrested and booked into jail. A quantity of methamphetamine, and heroin was located and seized. The SLCO Health Department closed the residence to occupancy.
- On 9/14/2014, Detective Fowler located two (2) unoccupied stolen vehicles and recovered them. He also located a stolen car in the Savers parking lot. He observed a male adult approach and enter the car. He was non-compliant and forcibly taken into custody. He was in possession of methamphetamine, stolen IDs, credit cards, and keys to other vehicles.
- On 9/17/14, Detective Fowler received information that a stolen car from Taylorsville had been located in Summit County near a residence that had just been burglarized. An Audi had been stolen from the garage. Detective Fowler began driving through apartment complexes and located the stolen Audi at a Taylorsville Apartment complex. A tracking device was placed on it. A short time later, the car left the area and surveillance units were able to effect an arrest. He admitted to committing the burglary in Summit County and was turned over to their Detectives.

- On 9/19/14, Detective Fowler located a stolen vehicle parked outside of a Taylorsville business. When two adults got into the car, Detective Fowler and patrol units moved in and took the occupants into custody. Over ¼ ounce of methamphetamine, heroin, drug paraphernalia, and stolen property were recovered. Both were booked into jail.
- On 9/23/14, Taylorsville NSC and DEU detectives assisted in the capture of three adults who had fled from Officer Riggs. The male adult driver was apprehended and a female adult was located by Detectives a few blocks away. She was found in possession of methamphetamine and drug paraphernalia.
- On 9/22/14 and 9/23/14, Detective Ikemiyashiro and Detective Lloyd conducted parking enforcement at Calvin Smith Elementary in response to several complaints.
