4. BUSINESS MANAGER REPORT

a. Monthly Summary

Dr. Justis and Ms. Barton presented the financial updates:

- Playground Project: Construction starts after June 5th; most savings have been utilized, but future funding may improve stability.
- Donation and Endowment: A family has started an endowment to help with expenses, but it won't cover the entire shortfall.
- Managing Costs: Clear communication about donations is needed to avoid misunderstandings about fees.

- b. Approval of FY26 budget (vote)
 - i. Discuss closing of after school club

 Dr. Justis discussed next year's budget, highlighting possible cuts of \$60,000 to \$90,000 due to reduced Higher Education

 Funding, affecting the after-school club, which is currently subsidized by \$40,000 annually. Fortunately, the Boys and Girls Club is interested in running a similar program at a comparable cost. Janelle, the current director, has successfully revived their operations and will provide staff training and curriculum, needing only space from us.

Dr. Justis also mentioned potential slight reductions in other areas, including employee Christmas gifts, with an operating surplus of about \$31,000 and plans to cut travel expenses. If funding cuts are less severe, there are opportunities for more behavioral consulting and resources.

Questions about the budget revealed that amendments typically occur in October or November after audits, with projections based on university suggestions. The Boys and Girls Club will still accommodate EBLS students.
