In accordance with Title 73, Chapter 4 of the Utah Code, the State Engineer has researched and investigated claims to the use of water, both surface and underground, in the Provo City South Subdivision of the Utah Lake and Jordan River General Adjudication. The Proposed Determination is the State Engineer's recommendation to the Court of how all rights in the Provo City South Subdivision shall be determined.

The Provo City South Subdivision Proposed Determination will be on file with the Clerk of the Third Judicial District Court in and for Salt Lake County located at 450 State Street, Salt Lake City, UT. Additional copies may be obtained, upon payment of the cost of duplication, from the Division of Water Rights at 1594 West North Temple, Salt Lake City, UT.

Any claimant who desires to object to the Provo City South Subdivision Proposed Determination must file a written objection with the Clerk of the Third Judicial District Court in and for Salt Lake County. A copy of the objection should also be filed with the Division of Water Rights at the following address: Division of Water Rights, Adjudication Section Manager, 1594 West North Temple, P.O. Box 146300, Salt Lake City, UT 84114-6300. Objections to the Provo City South Subdivision Proposed Determination must be filed within **ninety (90) days** of the date of this notice.

The State Engineer will be holding a **public meeting on April 3, 2025 in the Multi-Purpose Room of the Provo Recreation Center located at 320 West 500 North, Provo, Utah from 6:00 p.m. to 7:00 p.m.** to meet with water users and discuss the Provo City South Subdivision Proposed Determination.
