Virgin Town – Residents Survey Summary

Virgin Town developed this survey as a part of updating the General Plan. The survey was conducted online and with paper copied distributed from the middle of November 2024 through December 14, 2024.

The survey reflects a wide range of views from the residents who filled out the survey. Fifty paper surveys were completed, and 61 online surveys were completed for a total of 111 surveys.

Written comments on surveys completed on paper were transcribed, and online comments were copied and pasted. Many of those who completed the survey did not answer every question. As a result, the numbers of responses vary from question to question.

The 45 years and older age groups completed 77.9% of the surveys, though they represent 47% of the population. The 18-44 years age group completed 22.1% of the surveys, and represent 20.7% of the population. The remaining 32.3% of the population are under 18 years of age. Of those who responded, 54.7% have lived in Virgin 10 years or less. Those who have lived in Virgin Town more than 20 years made up 16.0% of responders, while the remaining 29.2% have lived in Virgin between 11-20 years. One person households were 6.0% of responders, two person households represented 73.0% of responders, three or more people per household made up 21.0%, with the largest household reported being one household with 6 people. A number of the surveys were completed by members of the same household and reflected similar views.

The results of the survey are used by the Planning Commission and Town Council to understand the various viewpoints of community members as they update the General Plan.

Results that could be calculated are given in numbers and graphs. All comments are recorded, with a bullet point for each comment. Comments written in [brackets], are for clarity where handwritten comments included strike throughs, arrows and other marks which are not written words. Some spelling was corrected. Less than a handful of comments, which were accusatory, were removed.

Below are the survey questions, tabulations of responses, and written comments/responses.


Virgin's Current Vision Statement


"We will create a community that promotes a safe, comfortable, neighborly environment that adds to the beauty of the scenic surroundings by:

- 1. Encouraging principles of abundance and collaboration for all citizens.
- 2. Fostering a community with economic growth and stability for families to live in and enjoy.
- 3. Providing opportunities for others from around the world to also enjoy the atmosphere and beauty of the area.

- [Crossed out the numbered statements] 1. Limiting growth thereby protecting the environment and our very limited natural resources. 2. Fostering a community with beautiful additions such as walkways and paths, flower boxes and sculptural highlights from our natural rocks. 3. Providing tourists with an oasis in the desert with affordable drinks and refreshments, places to read the history of our area, and take photos.
- What does this apply to? [crossed through "abundance" in #1] No subsidized housing. What opportunities? And why should we provide for others from around the world?

- Growing sustainably with our resources and remaining a town for working people and families can be comfortable living in.
- I'm sure it wasn't the intention, but this sounds tailor-made to enable more RV parks. I would love to see a mission statement more centered around preserving the natural surroundings and access to them, with an emphasis on the quality of life for the majority of people who live here rather than a tiny number of commercial endeavors.
- While we agree with the initial mission statement, the following three points are too vague and don't even address safety or neighborliness, other than encouraging collaboration. It does not state how the beauty of the scenic surroundings is going to be protected and what adds to the beauty rather than detracts from it as several approved projects from previous councils have unfortunately done.
- Keep Virgin a beautiful, quiet and sustainable town for residents.
- While maintaining its small country charm
- Visitor opportunities should not disrupt the natural beauty of the area, like the white tents on the east hillside or the bright orange restaurant or anything else like it.
- I don't want to lose the small town feel of Virgin.
- Virgin has become ugly/trashy from way too much development and too many people.
- Not really sure this captures a theme. Vague and nebulous.
- There is too much emphasis on "providing opportunities" for people who don't live here, and not enough emphasis on making improvements that benefit the citizens of this town.

- Small, formerly rural town, trying to maintain its character with all the increasing commercial development all around.


- Walkable, quiet neighborhoods, strong sense of community, diversity of residential housing, enabling diverse economic (income) levels to call Virgin home







Why do we allow more and more commercial development? ¶ Whereas LaVerkin & Hurricane have existing access to sewer, do not have flooding issues (both river & dry washes) that Virgin does, are closer to schools and well-paying employment opportunities it seems to me they are much better suited for dense development. ¶ Virgin should identify our unique qualities, our difficult to overcome geologic & hydrologic challenges, and plan for development accordingly, protect our quality of life and avoid very expensive mistakes. ¶ Availability of water & sewer only exacerbates demand from out-of-town developers to turn our community into their cash cow. ¶ We only need enough commercial to pay for community needs. ¶ My wish for Virgin is for it to remain a predominately owner-occupied residential community. Limit residential developments that are investor-owned, affordability may not be a solvable challenge for a gateway community with our constraints.
