

EAGLE MOUNTAIN CITY NOTICE OF PUBLIC HEARINGS

The Eagle Mountain City Council will hold public hearings on **June 17, 2025, at 7:00 PM** or as soon thereafter as business allows, in the Eagle Mountain City Council Chambers, 1650 E Stagecoach Run, Eagle Mountain, Utah 84005. The City Council will receive public comments concerning the following items:

FY 2026 Budget Adoption:

- State statute requires that the City Council hold a public hearing on the tentative budget and that the budget be adopted by June 30. The tentative budget was accepted by the City Council on May 6, 2025, and a public hearing was held on June 3, 2025. This is the final public hearing. EMMC 2.2 Compensation Schedule of Statutory Officers:

- Pursuant to UCA 10-3-818, a Public Hearing is Being Conducted to Consider Public Comment on Proposed Compensation Increases for Statutory/Executive Officers in the Fiscal Year 2025-2026 Budget.
