- Welcome
  - Megan welcomed the group and opened the meeting.
- Summary / Follow Up to Immigration Impact Discussion
  - The discussion was an open forum format, with thorough participation between the council members and the invited guests. Information was shared from multiple entities, and Megan has sent out any documents that were forwarded to her from the guests. Notably one really impactful document was the Community Health Assessment (CHA).

- Legislative Recap
  - HB167: this bill allows criminal justice coordinating councils to add additional members if they choose to, such as a representative from a college/university. The bill also adds a purpose for CJCCs, which is to strategize ways for local employers to hire people leaving the criminal justice system (either on parole or probation), and to find ways to better connect those individuals with resources available in the county (housing, therapy, etc).
  - Aaron: there are several new bills that were approved that have interaction with the jails, the courts, and behavioral health. It might be beneficial to pull a few members from this council to work on complying with these bills.
- Pretrial Services Update
  - Aaron: we've received our first reimbursement payment for the equipment we've purchased; however, we're still sitting on a lot of money that needs to be spent for this grant. Aaron would like to see the Pretrial Services group (Kacey, Cliff, Brad, and himself) come back together so that they can brainstorm the best way to spend the remaining budget for this grant. There's roughly \$80k left.
- Court Documents Translation Update
  - Aaron: this project is a part of the same grant as the pretrial services project; Cristie was running the management of the translation project, and since she's moved on from her position as SCAO Victim Advocate Program Director it is unclear where the translation project is at this time. Megan will check with Pepe to see where the project was left at and where it needs to go from here.
- Review Strategic Plan Goals for 2025
  - The Strategic Plan didn't get sent out to everyone in the council yet so this item will be postponed until the next meeting.
- Council Comments on Current Criminal Justice Issues
  - Drivers License Course: Dan from the Summit County Library was collaborating with Park City PD to work on an online course. Frank confirms that the sheriff's office is working with them as well. He's moved two of his officers around so that they can be involved in this project, one of whom is a fluent Spanish speaker. Frank will get an update to Megan for this project.
