- **Item No. 2 Timber Brook Homes Rezone Request:** The Planning Commission will review, discuss and may move forward with setting a public hearing for a rezone request for parcel 02-096-0048 located in the general area of 314 W 100 S Providence UT Request seeks to rezone parcel from AGR to R-1-6.

(ANALYSIS) (PARCEL SUMMARY) (APPLICANT PRESENTATION)

- Shelly Nazer called item 2, gave a brief introduction and asked Skarlet Bankhead to give an overview of the request.
- Skarlet Bankhead presented information on the rezone request for parcel 02-096-0048 located at 314 W 100 S Providence, UT. She explained that the application was received on April 28th. The purpose of the request or application is to change the zoning from AGR to R-1-6. This is a study item to review the application before making a recommendation to the city council. A public hearing will be held before making a recommendation. This review focuses on zoning, not specific development designs.
- Mrs. Bankhead reviewed relevant sections of the general plan, moderate income housing plan, and city code. She noted the proposed zone supports key initiatives and housing strategies, but does not guarantee unit pricing. The area has good access to parks and trails. Infrastructure requirements would be addressed at the building permit stage.
- She noted that various city plans were considered when reviewing this rezone, including transportation, parks/trails, water, and sewer plans. She noted that the area has few geographical constraints for development.
- She reviewed with the Planning Commission the use chart comparing zones in the surrounding area.
- Dalen Tolman, owner of Timber Brook Homes, presented on his rezone request. He stated that their focus is providing affordable homes under \$450,000-\$500,000. They offer custom features like tile showers and quartz countertops. Noted that many plans are single-level with no steps.
- Their requesting the R-1-6 zoning due to frontage requirements, not lot size. Most proposed lots would still be over 10,000 sq ft. Reported that the existing house would remain on a half-acre lot.
- The Commission asked questions about road width, parking, bike lanes, irrigation plans, and reasons for the R-1-6 request versus other zones.
- Reese Peterson, a nearby resident, commented that he is not opposed to the development. He described the irrigation ditch locations in the area and possible issues. He suggested larger lot sizes similar to nearby developments. He recommended considering a dog park or additional parking.
- The Planning Commission discussed the next steps.

- **Item No. 3 Planning Commission Bylaw Amendment; Bylaw 3.2:** The Planning Commission will discuss amending Planning Commission Bylaw 3.2. **(AMENDMENT PROPOSAL)**

- Shelly Nazer called item 3, gave a brief introduction and asked Bob Washburn to present the amendment.
- Bob Washburn proposed amending Planning Commission Bylaw 3.2 regarding elections for commission chair and vice chair. The amendment would allow candidates to express interest and qualifications. Require candidates to confirm willingness to serve and allow all commission members, including non-voting members, to vote on leadership positions.
- The commission discussed the proposal, including voting requirements and procedures.

- **Item No. 4 Providence City Code 10-8-4 Review and Discussion:** The Planning Commission will review and discuss PCC 10-8-4 **(10-8-4 HEIGHT)**

- Shelly Nazer called item 4, gave a brief introduction and asked Bob Washburn to lead the discussion.
- Bob Washburn introduced discussion on Providence City Code 10-8-4 regarding building height regulations. He noted that there are ambiguities and conflicts in the current code language versus

graphics. He commented that enforcement has become more stringent recently, causing issues for some builders. Advised that the Commission should consider clarifying the code and its enforcement.

- Nathan Ballstead, a local builder, provided input. He suggested basing height on street view rather than average grade. Commented that the current averaging method causes issues on sloped lots. Builders are adding fill and retaining walls to meet requirements, increasing costs. He questioned when the current language was added to the code.
- The Commission discussed: Reasons for height restrictions (aesthetics vs. safety). Impacts on views and neighboring properties. Challenges with hillside lots and finished grades and enforcement difficulties after initial approval.
- Skarlet Bankhead explained that staff are researching other cities' approaches, especially for hillside development. Graphics in the code can or should be updated to match written language. Noted that substantial changes should follow the formal code amendment process.
- Staff will continue to gather input from the fire department and building officials.

Motion to continue the discussion at the next meeting, with staff to report on fire department and county input, and research other mountain town ordinances if time allows. – Joe Chambers. 2nd- Bob Washburn.
