III. Preliminary FY26 Budget (Bud, Tess, Casey)

Bud Canaday provided an overview of the budget for 2026. He highlighted the current budget was very tight. The finance committee members felt justified in increasing the forecasts for interest income and annual fundraising. Both moves were above previous conservative estimates, but not outlandish or unrealistic. Tess miner-Farra provided in- depth explanation about State funding formulas which rest on average daily attendance and student body count on October 1. This was a highly relevant topic because the change in the calculation resulted in decreased funds for the 2026 year.
